COG proposes to drill a **VERTICAL** NW /4, 40 acre spacing
Maljamar; Yeso oil well
TD of approximately 7200'

Location: 1460' FNL & 420' FWL Sec 19, T17S, R32E, Unit E

This well had to be drilled at a non-standard location
due to pipeline constrictions.

The plan for this well is to complete it in the Yeso formation.
We won't know the exact perms until we drill & log it, but it will be very similar to
the B C Federal #12 (330' FNL & 1750' FWL, Section 19, UL C) which was
completed in July 2006.

The B C Federal #12 completion broke the Yeso up into 3 perf/stimulation
intervals. B C Federal #12 has perms from: 5806.5' – 6709.5' overall, but broken
up into 3 separate intervals, with 3 separate fracs

1st interval: 6589' – 6709.5',
acidized w/ 2500 gals,
frac'd w/ 97,940 gals gel, 8,000 # LiteProp, 90,060# 16/30 sand.

2nd interval: 6249' – 6505',
acidized w/ 3000 gals,
frac'd w/ 75,000# gal gel, 8012# LiteProp, & 90,460 gals 16/30 sand.

3rd interval: 5806.5' – 6162',
acidized w/ 1600 gals,
frac'd w/ 75,000# gal gel, 8000# LiteProp, & 90,520 gals 16/30 sand.

At this time, we assume the B C Federal #19 should be very similar.
