Bravo Operating Company requests approval for an unorthodox well location for the subject well. The Mesa Macho No. 1 is currently completed in the Morrow in a previously approved unorthodox location.

In order to test the Strawn formation on this lease economically, it will be necessary to use the existing wellbore. Therefore, approval of this location for a Strawn well is necessary. Enclosed is a copy of the C-103.
