Dear Mr. Stogner:

Union Oil Company of California (UNOCAL) requests permission for a nonstandard location for our Rincon Unit No. 130E well, located 2040' FSL, 2060' FEL, Section 32, T27N, R6W, Rio Arriba County, New Mexico.

This well is a proposed dual South Blanco Tocito Extension/Basin Dakota well. In order to place this well within the narrow South Blanco Tocito drilling window (shown on Attachment A), this well was staked 210' west of the orthodox Basin Dakota window. This places the well deeper within the Rincon Unit and further from offset leases.

The dedicated spacing unit is shown on Attachment B. The offset lease owner, Caulkins Oil Company, has waived any objection to this nonstandard location. This letter of waiver is also attached.

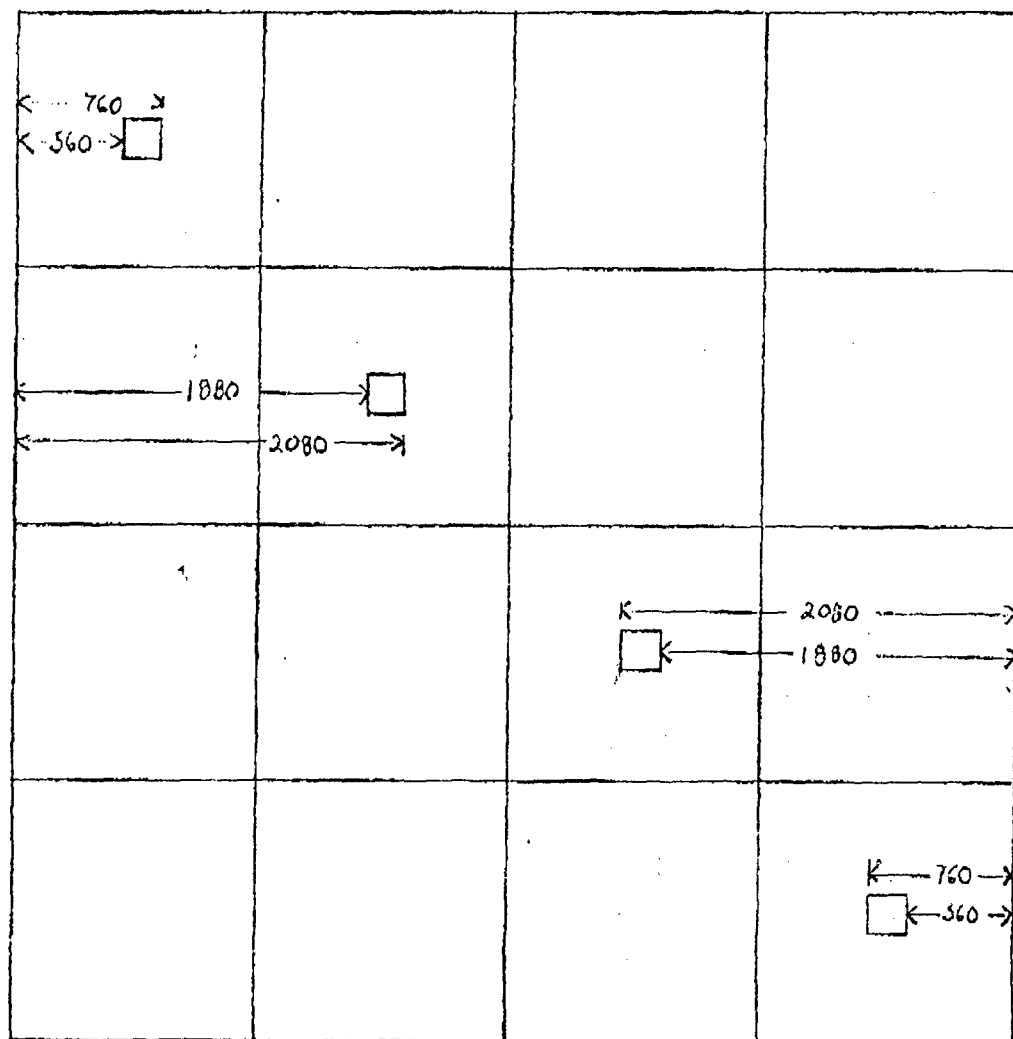

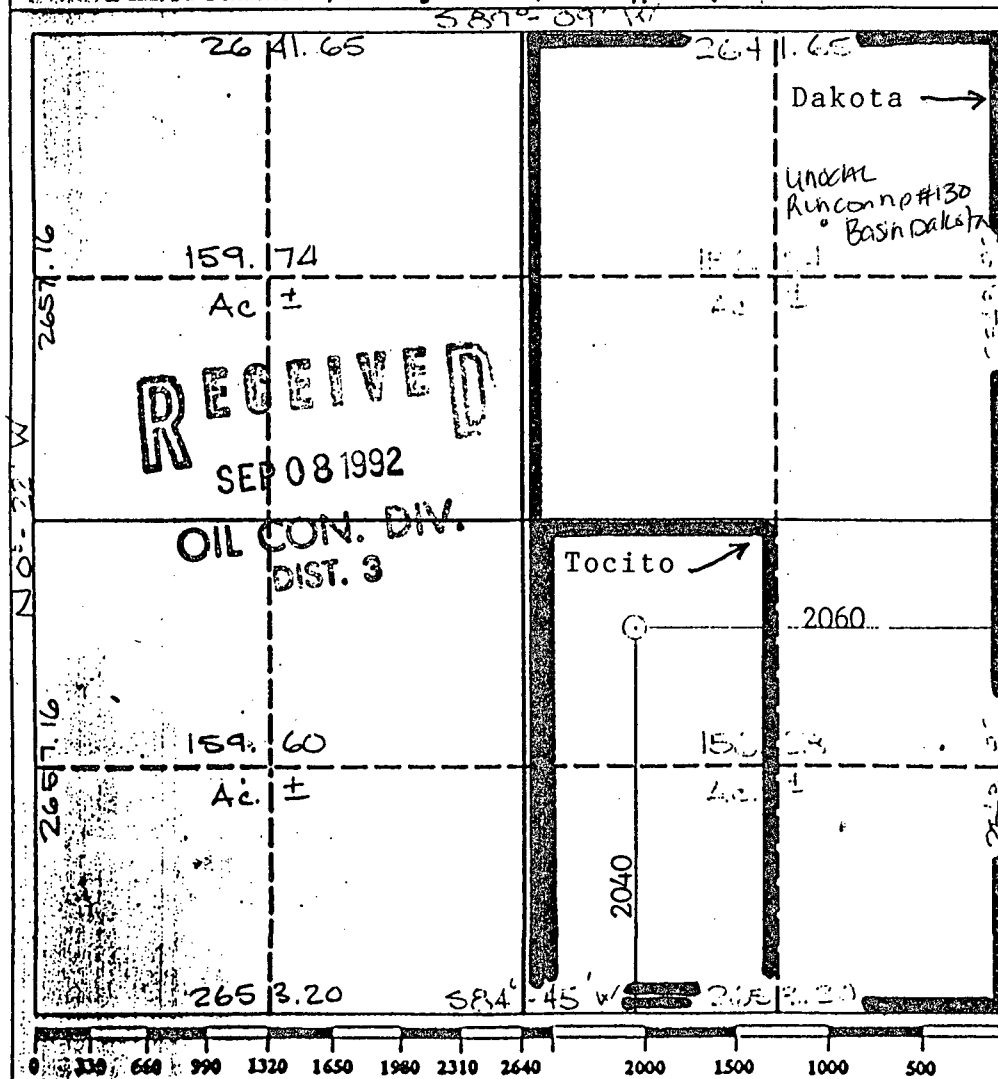
