Gentlemen:

Chevron U.S.A. Inc. respectfully requests your approval of this administrative application for the subject Unorthodox Gas Well Location and Simultaneous Dedication.

Chevron has recently re-completed its **Arnett Ramsay (NCT-D) Well No. 14** in the Eumont Yates 7 Rvrs Qn (Pro Gas) Pool. This well was originally completed as a Eumont Oil well in July 1960. It was later TA'd in May 1984 due to lack of production. It was on the OCD's list of SI/TA wells requiring remedial action this year.

It is our desire to simultaneously dedicate the existing 320-acre Eumont Gas Proration Unit assigned to our **Arnett Ramsay (NCT-D) Well Nos. 3 and 15** (Administrative Order NSP-607 & OCD Letter Dated 1/16/79) to all three wells. The 320-acre gas proration unit will comprise the N/2 of Section 33, Township 21 South, Range 36 East, Lea County, New Mexico.

As a result, the location of the **Arnett Ramsay (NCT-D) Well No. 14** is unorthodox in that it is less than 990' from the outer boundary of the proration unit. The location of Well No. 14 is 1980 feet FNL and 660 feet FEL, Unit Letter H, Section 33, Township 21 South, Range 36 East, Lea County, New Mexico.

In order to prevent waste, Chevron respectfully requests your approval of this administrative application for an unorthodox gas well location and simultaneous dedication. Attached is a map showing offset operators and a Form C-102 plat. A copy of this letter and attachments are being furnished by Certified Mail to offset operators as their notice of this application.




COMMERCIAL MAP
