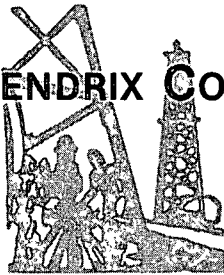

John H. Hendrix Corporation respectfully requests administrative approval for the creation of a non-standard 80 acre Blinebry Gas Proration Unit for the Hinton #13, consisting of the S/2 SW/4 of Section 12, T22S - R37E.

The well currently has a 160 acre proration unit. Due to the producing capacity of the well, an 80 acre proration unit is sufficient for allowable purposes.
