Re: Application of Texland Petroleum-Hobbs, LLC, for administrative approval of an Unorthodox well location for its Dobry Well No. 1, to be drilled to the Devonian formation at a surface location 1165 feet from the North line and 2175 feet from the East line of Sec. 33, Township 16 South, Range 38 East, N.M.P.M., Lea County, New Mexico.

Dear Mr. Fesmire:

Texland Petroleum-Hobbs, LLC ("Texland") hereby seeks administrative approval pursuant to the provisions of Division Rule 104 F (2)-(4), of an unorthodox well location as a Knowles Devonian, West for its Dobry Well No. 1 located 1165 feet from the North line and 2175 feet from the East line of Section 33 (Unit B), Township 16 South, Range 38 East, N.M.P.M., Lea County, New Mexico.

This proposed location in the Devonian formation is unorthodox because it is governed by state wide rules which provides for wells on 40-acre spacing units to be located 330 feet from any boundary of the spacing unit. The proposed unorthodox well location is at 155 feet from the southern boundary of the proposed spacing unit. A standard 40-acre spacing unit and proration unit comprised of the SW/4 NE/4 of Section 33 will be dedicated to the well.

The non-standard location is required by geologic conditions; as shown on the attached **Exhibit "A"**, and by an existing irrigation pivot, as shown on the attached **Exhibit, "A1"**. The location is positioned to encounter the Devonian pay zone at the highest point possible, above the nearby oil-water contact (shown in blue). A well drilled lower on the anticlinal structure has considerable risk of encountering only water in the pay zone.


Exhibit "B" is the C-102 filed for the well that shows the surveyed location of the well.





Texland Petroleum L.P. (Texland) has applied for a permit to drill a Devonian test well on the following unorthodox location in the NW/4 NE/4 Section 33 T18S R38E, Lea County, New Mexico:

1165 feet from the north line Section 33
2175 feet from the east line Section 33

The leasehold ownership in the SW/4 NE/4 Section 33 is identical in the Devonian Formation. Accordingly, there are no additional parties to be notified of Texland's drilling permit application for this unorthodox location.
