Mr. Hansen,

Pursuant to our phone conversation regarding soil activities to be conducted at the Plains Hugh Gathering release site AP-041, Plains would like to add the following modifications to the existing approved Abatement Plan to meet the requirements set forth by the landowner. The OCD approved Abatement Plan specifies excavation of impacted soil to a depth of 15 feet bgs, at the request of the landowner the total depth of the excavation will be 19 feet. Two passive 4-inch SVE wells will be installed in the base of the excavation. These wells will be installed from 19 feet bgs to approximately 35 feet bgs through the impacted area. Soil samples will be collected during installation of these wells to insure proper placement in the impacted area. Additionally two borings will be installed adjacent to the SVE wells which will be utilized to apply Micro Blaze solution. The base of the excavation will be saturated with Micro Blaze prior to the installation of the clay liner. The SVE wells will be extended to the surface and the excavation will be backfilled with clean material. A down gradient monitor well will be installed approximately 100 feet to the southeast of the excavation and sampled quarterly.

Upon OCD approval Plains will proceed with the remediation activities described above.
