APPLICATION

Applicant, Turner Production Company, pursuant to Rule 104 (I), requests administrative approval of an unorthodox location and in support thereof states:

1. Applicant is the operator of the Turner 26 Well No. 1 located in Unit I, Section 26, Township 26 N, Range 7 West, Rio Arriba County, New Mexico.

2. The Turner 26 Well No. 1 is presently completed for Chacra and Pictured Cliffs oil and gas production within the Otero Chacra and the South Blanco Pictured Cliffs pools.

3. The Turner 26 Well No. 1 is dedicated to the SE/4 of Section 26 and is located 790 feet from the East line and 1,460 feet from the South line of Section 26.

4. The gas reserves in the presently completed producing zones of the subject well have reached an economic limit under which further production is no longer economically feasible.

5. Applicant desires to recomplete the Turner 26 Well No. 1 in the Fruitland Coal Formation in order to test the producing capability of the Fruitland Coal Formation.

6. In the event that production is obtained from the Fruitland Coal Formation within the Wellbore of the Turner 26 Well No. 1 the applicant will dedicate the S/2 of Section 26 to the well.

7. Approval of this Application will be in the best interests of the conservation of oil and gas and will prevent economic waste by eliminating the necessity of drilling another well to test the Fruitland Coal Formation.


8. Attached hereto as Exhibits 1 and 2, respectively, are a plat of the area of the Turner 26 Well No. 1 and a list of offset operators.

WHEREFORE, Applicant prays that this application be approved in its entirety and for any other relief deemed appropriate by the Division.

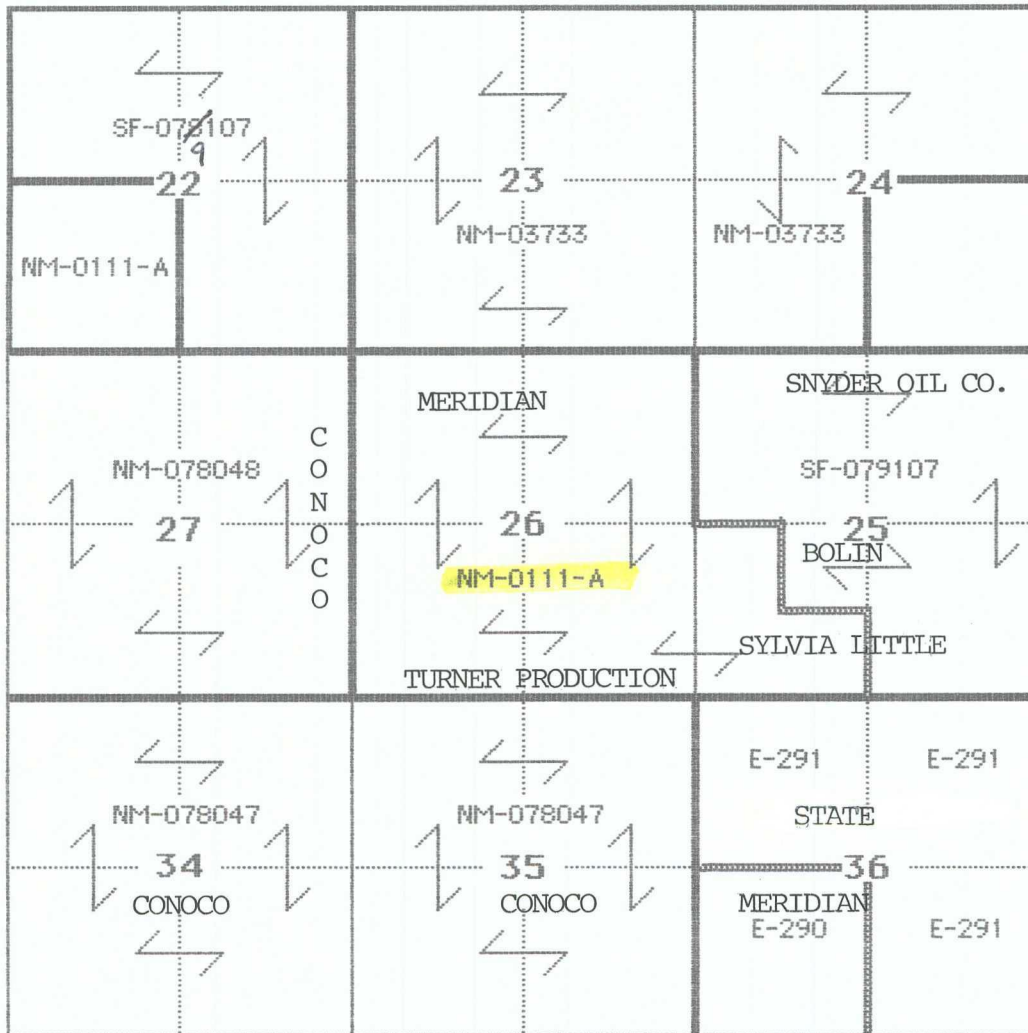


