Describe Cause of Problem and Remedial Action Taken *

A third party working in the area of a DCPM pipeline notified a DCPM Field Operator of a leak on the Eddy County Loop line (COP line #12200). The leak had been ongoing for sometime prior to discovery; therefore, the extent of the contamination is unknown.

Describe Area Affected and Cleanup Action Taken *

The area affected was the pipeline right of way just east of hwy 238 approx. 0.5 miles. Depth to groundwater is presumed to be 50 ft. bgs. All effected soils will be tested for TPH and BTEX (process knowledge constituents of DCPM pipeline), remediated, and hauled to an NMOCD approved disposal site. After all contaminated soil is removed; this location will be backfilled with soil approved by the NMOCD.

I hereby certify that the information given above is true and complete to the best of my knowledge and understand that pursuant to NMOCD rules and regulations all operators are required to report and/or file certain release notifications and perform corrective actions for releases which may endanger public health or the environment.
