Gentlemen:

An Exception to Rule 104 F. III, by administrative approval, is requested for Texaco Exploration and Production Inc.'s L. L. McConnell Well No. 15. This well is located 2310' FSL & 330' FWL, Unit Letter "L", of Section 29, T-25-N, R-3-W.

This well must be drilled in this location due to topographic conditions and the presence of archaeological sites. The attached letter dated January 10, 1994 from Property Management & Consulting, Inc. details the reasons for requesting this exception.

We believe drilling a directional well to reach a legal bottom-hole location is not feasible due to the cost involved. A pumping completion is anticipated and the associated costs of pumping, as well as drilling, a directional well severely impact the already marginal economics of this well.

The offset operators to this location have been notified (certified receipts Texaco grants itself a waiver to the unorthodox location. attached). Attached is the C-102, archaeological report, regular topo map, enlargement of topo map, location layout, cut and fill, and offset operators list.

Dear Royce:

Property Management & Consulting, Inc., working in conjunction with NCE Surveys and Moore Anthropological Research, conducted an onsite inspection of the potential locations for Texaco's L. L. McConnell No. 15 location.

To be orthodox both for the Blanco, Mesa Verde gas pool and West Lindrith Gallup - Dakota oil pool, the location would have to be staked in one of four (4) - 200' X 200' windows created by offsetting 790' from the section and quarter section lines and 330' from the quarter - quarter section lines in the SW 1/4, Sec. 29. T29N, R3W. See attached exhibits No. 2 and 3.

The drilling window in the NE SW was eliminated due to steep topography: 1) Cliffs on the north, west and east sides and steep topography to south coupled with the presence of numerous archaeological sites makes access to this window impractical. 2) Steep topography within the perimeter and surrounding vicinity of the window would require cut and fill slopes exceeding 30 verticle feet, making location construction impractical.

The drilling window in the SE/SW was eliminated due to the presence of an archaeological site.

The drilling window in the NW/SW was eliminated due to the presence of an archaeological site.

The SW/SW window was eliminated due to archaeological sites on the east and south sides coupled with a sheer bluff running north south through the center of the window and steep topography on the west side. Texaco's L. L. McConnell No. 8 location located 990' FSL & 990' FWL, Sec. 29 was onsited for a potential shared location for the L. L. McConnell No. 15. This location is orthodox for both the West Lindrith Gallup - Dakota and for the Blanco, Mesa Verde, however, this location had to be eliminated due to archaeological scatter indicative of the location being linked to the archaeological sites to the north and south.


We were able to locate a suitable surface location for the L. L. McConnell No. 15 well, as staked, 2310' FSL & 330' FWL, Sec. 29, T25N, R3W. This location is orthodox for the West Lindrith, Gallup - Dakota oil pool, but unorthodox due to the reasons discussed, for the Blanco, Mesa Verde gas pool. It is located as close as practical to the NW/SW Blanco, Mesa Verde drilling window due to the presence of an archaeological feature to the east and steep topography to the south and southeast.


This location was onsited by the surface owner, Mr. Tony Schmitz, and BLM representation, Mrs. Pat Hester on June 10, 1993.






Scale: 1075'/ inch Archaeological Site: Location Size (includes 50' construction zone):

WELL LOCATION AND ACREAGE DEDICATION PLAT



This letter is in regard to the attempt made to move the Texaco well pads L.L. McConnell #15 and #16 to orthodox locations.

L.L. McConnell #15:

N.E. Window: Topographic Problems.

N.W. Window: A reconnaissance survey showed an unrecorded Gallina lithic and ceramic scatter that extends all along the knoll which is in the center of this window.

S.E. Window: A previous survey of the area three years ago discovered an unrecorded Gallina Tower site and associated artifact scatter.

S.W. Window: This is an existing well location, which a reconnaissance survey showed had impacted a large Gallina Tower and habitation site. It is possible that the scatter in the N.W. window and the impacted site in this window are actually one large site.

L.L. McConnell #16: (Now #149)

N.E. Window: Reconnaissance showed an unrecorded Gallina lithic/ceramic/ groundstone scatter within this window.

N.W. Window: Previously recorded site LA 100647 (Gallina Tower) is within this window.

S.E. Window: Reconnaissance showed an unrecorded prehistoric hearth site within this window.

S.W. Window: Reconnaissance showed an unrecorded Gallina lithic/ceramic scatter on the extreme end of the ridge, which would be in the buffer zone of the proposed location. There were also numerous topographic problems,


