
A field inspection conducted on 2/19/2003 at the Centralized Surface Waste Management Facility Permit NM-02-0018 found the facility to be in violation of rule 313.

Rule 313 requires to protect migratory birds, all tanks exceeding 16 feet in diameter, and exposed pits and ponds shall be screened, netted, or covered.

Please bring the above mentioned facility into compliance with Rule 313 within 30 days form the dated listed on this letter.

There was a hole in the fence along the east side and a pipe that extended to the east side of the ponds. This is potential location for trucks to unload. possibly unauthorized dumping.

There was no oil on the ponds A is the north pond and B is the south pond.

There were several holes in the net and the net was not extended to the ground in all places.

OK Hot Oil services the ponds to remove the oil for reclaiming.

Leak detection sumps were dry.

There was a weather station box in the Southwest corner that may or may not be operable. It had a wind speed and direction indicator.
