Mobil Exploration & Producing U.S. Inc., (MEPUS), as agent for Mobil Producing Texas & New Mexico, Inc. (MPTM) requests administrative approval to plug back the subject well, which is currently producing out of the Drinkard, and produce it, as a gas well, out of the Blinebry.

Well No. 6 is located on the same proration unit as wells S.E. Long #5, #7 and #8 and is an unorthodox location, being 660' from the South line and 560' from the East line (Unit P) of Section 11, T-22-S, R-37-E, Lea County, New Mexico. #### Administrative Order SD-93-3

Dear Ms. Brown:

Per your application dated November 16, 1993, Mobil Producing Texas and New Mexico, Inc. is hereby authorized to simultaneously dedicate Blinebry Oil and Gas Pool production to the existing standard 160-acre gas spacing and proration unit comprising the SE/4 of Section 11, Township 22 South, Range 37 East, NMPM, Lea County, New Mexico, from the:

- S.E. Long Well No. 5, located at a standard gas well location 660 feet from the South line and 1880 feet from the East line (Unit O) of said Section 11; 30-025-10206
- S.E. Long Well No. 8, located 1650 feet from the South line and 2310 feet from the East line (Unit J) of said Section 11 (this location is considered to be unorthodox, however Rule 2 of the Special Rules and Regulations for the Blinebry Gas Pool, as promulgated by Division Order No. R-610, "grandfathered" this location in as conforming to the rules); and the 30-025-10209
- S.E. Long Well No. 7 located at a standard gas well location 1780 feet from the South line and 660 feet from the East line (Unit I) of said Section 11.

It is our understanding that the No. 7 well is currently a dually completed Drinkard and Wantz Granite Wash oil well and will be recompleted as a single Blinebry gas producer upon issuance of this order.
