Maljamar; Yeso oil well
TD of approximately 7000'

Location: 2410' FNL & 330' FWL Sec 22, T17S, R32E, Unit E

**This well had to be drilled at a non-standard location
due to pipeline and sand dune constrictions.**

The plan for this well is to complete it in the Yeso formation.
We won't know the exact perms until we drill & log it, but it will be very similar to
the M C Federal #10 (1650' FNL & 2310' FWL, Section 22, UL E) which was
completed in April 2007.

The M C Federal #10 completion broke the Yeso up into 3 perf/stimulation
intervals. M C Federal #10 has perms from: 5449' – 6873' overall, but broken up
into 3 separate intervals, with 3 separate fracs

1st interval: 5449' – 5620',
acidized w/ 1680 gals,
frac'd w/ 6023 gal gel pad, 42,071 gal gel, 5397 gals flush, 8000# LiteProp,
74,760# 16/30 sand, and 15,540# 16/30 SiberProp.

2nd interval: 5967' – 6310',
acidized w/ 2000 gals,
frac'd w/ 50,000# 20/40 white and 15,000# 16/30 sand.

3rd interval: 6513' – 6873',
acidized w/ 1650 gals,
frac'd w/ 48,538# 16/30 sand & 74,609 gal 40# gel.

At this time, we assume the M C Federal #31 should be very similar.

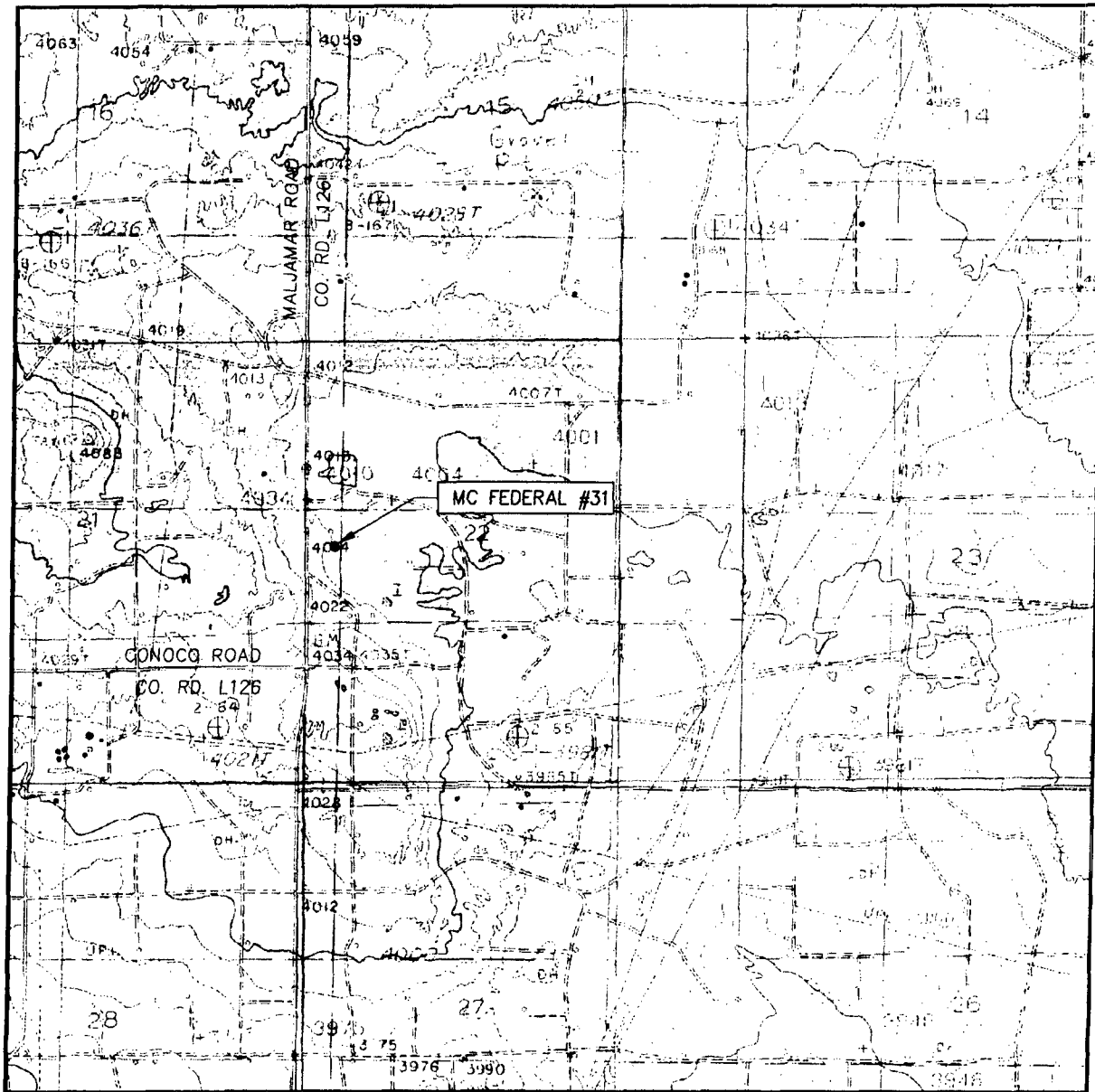

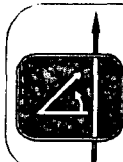
