We won't know the exact perms until we drill & log it, but it will be very similar to the M C Federal #11 (2460' FSL & 2210' FEL, Section 21, UL J) which was completed in August 2007. *NSL-5643*

The M C Federal #11 completion broke the Yeso up into 3 perf/stimulation intervals. M C Federal #11 has perms from: 5981' – 6854' overall, but broken up into 3 separate intervals, with 3 separate fracs

1st interval: 5981' – 6104',
acidized w/ 2000 gals,
frac'd w/ 98,658 gals gel, 8,000 # LiteProp, 96,680# 16/30 sand.

2nd interval: 6206' – 6527',
acidized w/ 2500 gals,
frac'd w/ 91,018# gal gel, 8000# LiteProp, & 88,500 gals 16/30 sand.

3rd interval: 6627' – 6854',
acidized w/ 1750 gals,
frac'd w/ 103,543# gal gel, 8000# LiteProp, & 89,800 gals 16/30 sand.

At this time, we assume the M C Federal #33 should be very similar.

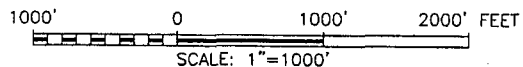
