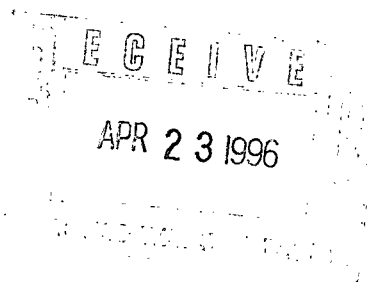



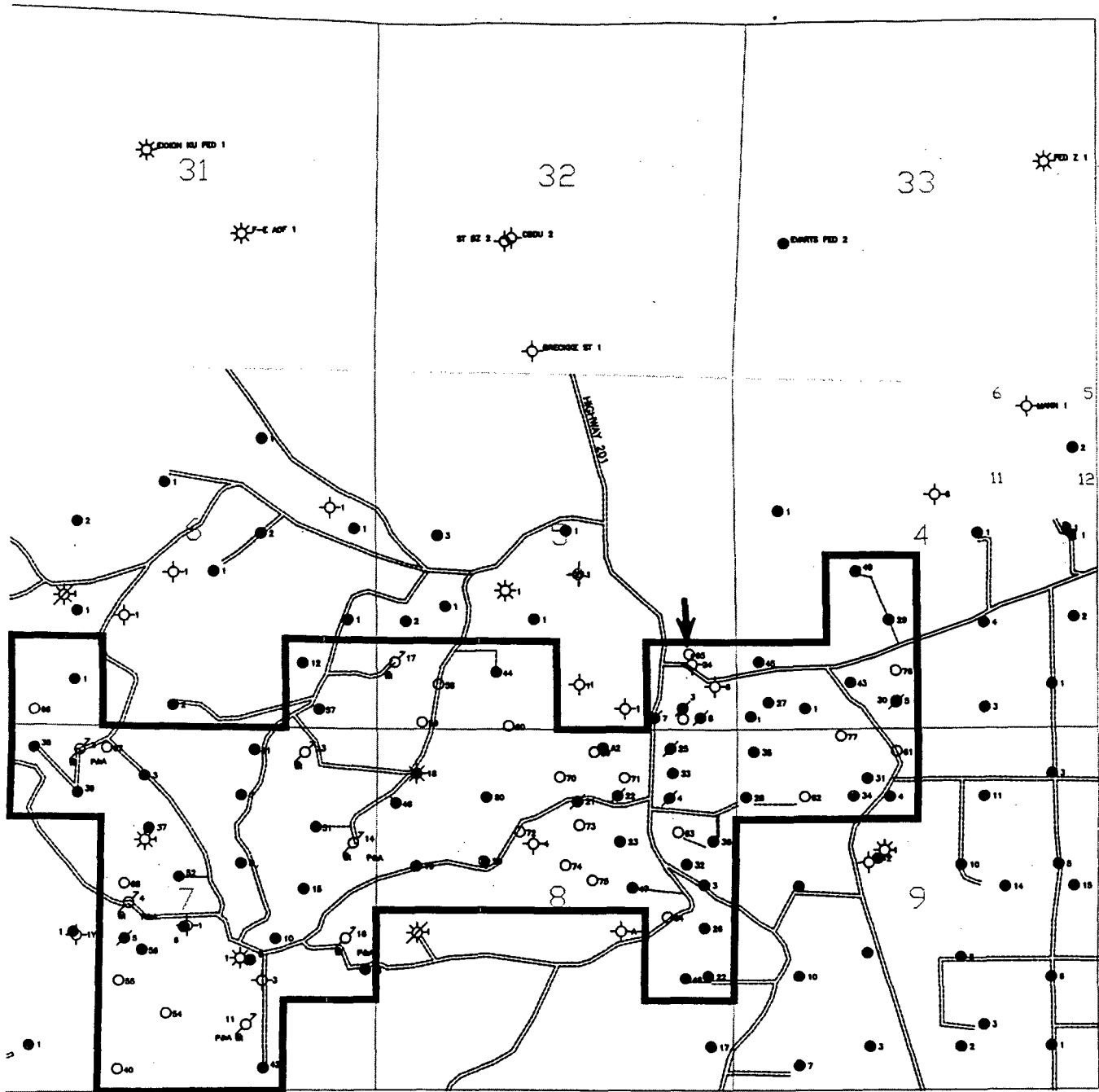

1. ABSTRACT:

An intensive archaeological survey of DEVON ENERGY CORPORATION's proposed West Red Lake Unit No.65 [**original location**](560' FSL; 990' FEL)(450' x 450', 4.64 acres) was conducted by Jon Blackwelder (Staff Archaeologist) on October 19, 1995. Mr. Ernie Buttross, DEVON ENERGY CORPORATION, requested the archaeological survey. Total area surveyed was 4.64 acres. The proposed project is located in Section 5, T18S, R27S, NMPM, Eddy County, New Mexico. One previously recorded site (LA 102896) was encountered during the archaeological survey.

A new location for the West Red Lake Unit No.65 [**moved location**] (1108' FSL; 691' FEL)(450' x 450', 4.64 acres) was surveyed by Jon Blackwelder on December 8, 1995, and Jon, Matt Lesniewski and Danny Boone (Field Technicians) on February 29, 1996. Total area surveyed for both locations was 9.28 acres.

Archaeological clearance is recommended for the DEVON ENERGY CORPORATION's proposed West Red Lake Unit No.65 [**moved location**], provided a fence is place 100' north of the proposed southern boundary of the moved West Red Lake Unit No.65 well pad area; all oil and gas activity for the West Red Lake Unit No.65 is restricted to the northern side of said fence; and access to the proposed well pad area be routed in from the western side of the location, connecting with Chalk Bluff Road (CR. 201). Monitoring of fence placement is also recommended.

3. PROJECT DESCRIPTION:

Well Pads (450' x 450' x 2, 9.28 acres). Total area surveyed and inventoried for cultural remains was 9.28 acres, east of the Pecos River, north of Little Diamond Road (CR 227), parallel to Chalk Bluff Road (CR 201).

TOPOGRAPHY:

The proposed project area is situated upon a moderately eroded area gradually sloping north toward an area drainage. Landform is incised with numerous ephemeral drainages, depositing into the larger drainage to the north. The location consists of sheetwash activity over indurated caliche soils, and scattered exposures of gypsum.

Soils: Reeves-Gypsum land-Cottonwood association: Loamy soils that are very shallow to moderately deep over gypsum beds, and Gypsum land

Vegetation: saltbrush, mesquite, prickly pear, tamarisk, creosote, snakeweed, yucca, christmas tree cholla, tree cholla, rainbow cacti and assorted grasses

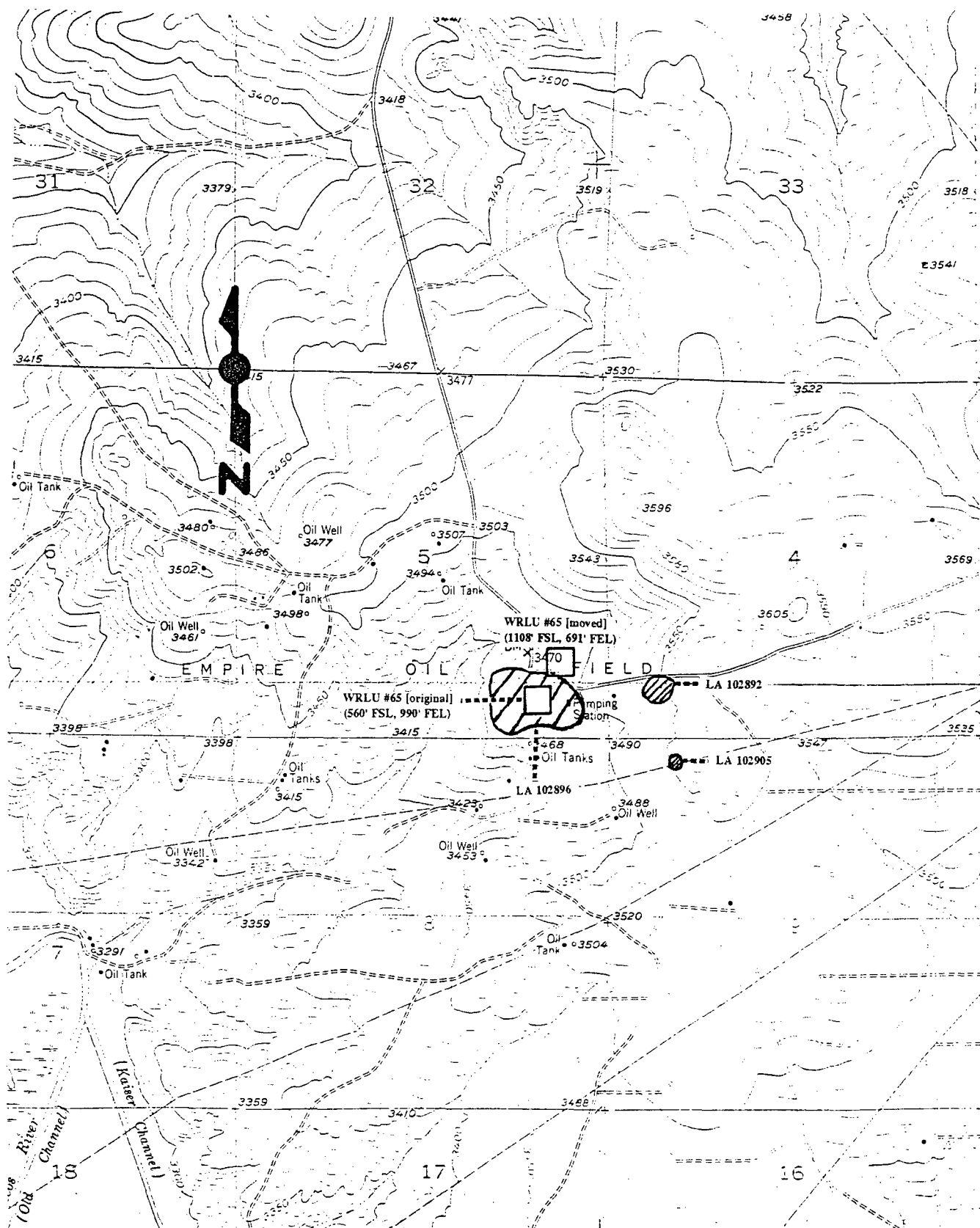

5. FINDINGS:

BLM prefield conducted by Arita Slate on October 19, 1995. According to BLM records, there are four previously recorded sites within a half mile radius of the proposed project area, however, if provided stipulations are followed, the closest site (LA 102896) will have a 100' bufferzone between it and the proposed project impact zone.

6. RESULTS OF SURVEY:

One previously recorded site (LA 102896) was encountered and updated during the archaeological survey of DEVON ENERGY CORPORATION's proposed well pad.

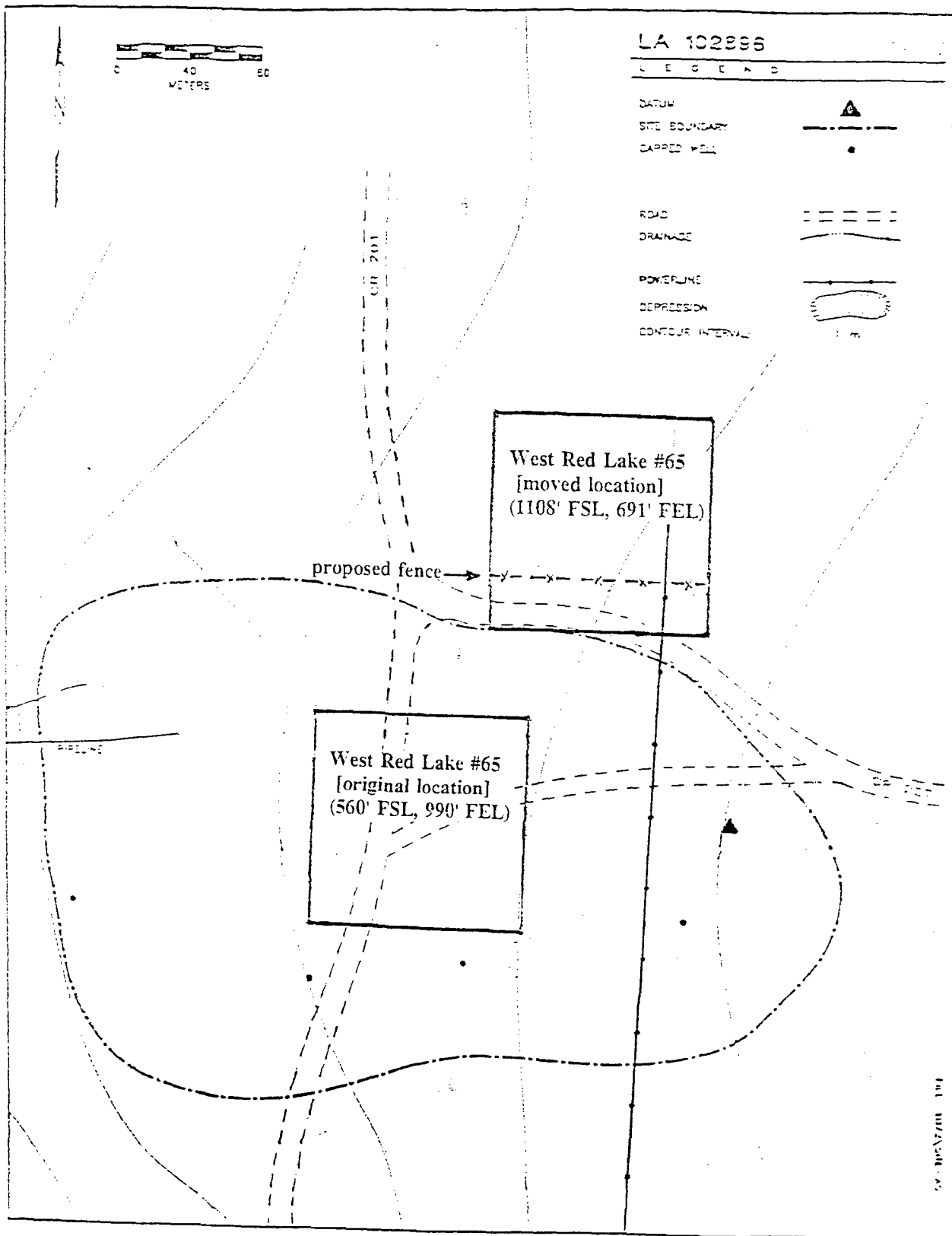


