

Geologic Justification for the Unorthodox Location of the Grayburg Deep No. 14 868'FNL,1062 'FWL Section 25, T17S,R29E, Eddy County New Mexico.

The Grayburg Deep #14 exploration well is located to test a northwest trending Morrow sand channel play. Previous mapping in the area showed that the Morrow channels are usually less than one-fourth mile wide and are following regional dip. The best location to test this Morrow channel sand in the 320 acre north lay-down in Section 25 is to the west and outside of the orthodox location boxes (see attached plat). Morrow sands are anticipated to have over 40 of net pay sand at the Grayburg Deep #14 location. The sands will thin and lose their reservoir quality to the east and west.
