

Re: Application for Administrative Approval Non-Standard Location Hanson B-2 Basin Fruitland Coal Pool W/2 Section 36, T27N, R13W San Juan County, New Mexico

Dear Mr. Lemay:

Merrion Oil & Gas Corporation plans to recomplete the subject well from the Gallup Formation into the Fruitland Coal Formation. The well's location of 1980' FSL and 1980' FWL is at a non-standard setback from the spacing unit boundary. Therefore, Merrion requests your approval of a non-standard location.

The justification for the request is based on the ability to recomplete the existing well instead of drilling a new well. The well is uneconomic in the Gallup Formation and, unless recompleted, needs to be plugged out. The proposed recompletion would put the wellbore to beneficial use and save significant money over drilling a new well.


