In regards to the remediation project on the above referenced well site, the NMOCD District 2 office is in receipt of analytical data obtained from this site on July 29, 2008. The data indicates contamination is present at this site that will require remediation by a Division approved workplan. This workplan needs to be formulated based on delineation of the contaminants present at the site. After a review of the photos and other information on this site, I believe some of the chloride impact present may be the result of leaching from the closed drilling pit. This may be something you would want to consider when preparing the workplan for the cleanup.

Please submit your workplan proposal to the District 2 office not later than September 15, 2008. Please provide 48 hours advance notice prior to obtaining samples where analyses of samples obtained are to be submitted to NMOCD.
