Describe Cause of Problem and Remedial Action Taken.*

Brine valve was left open at load line at east end of water station by 3rd party, line drained into diked area. Dike gave way and ran down lease road onto Chevron well location.

Describe Area Affected and Cleanup Action Taken.*

Affected lease road, Chevron State S #1 Unit D, Sec15-T21S-R37E well site and area surrounding. Recovered 275bbls with vacuum trucks. Terracon removed and disposed of 1762 cubic yards of brine affected soils on behalf of Key Energy Services. Excavated areas were backfilled with landowner provided top soil (1,010 cubic yards) and landowner provided caliche (300 cubic yards) to repair affected roads. Remedial actions documented in Terracon report dated February 20, 2008 (Attached). Disturbed topsoil will be reseeded at the landowner's direction with a landowner selected seed mix.

I hereby certify that the information given above is true and complete to the best of my knowledge and understand that pursuant to NMOCD rules and regulations all operators are required to report and/or file certain release notifications and perform corrective actions for releases which may endanger public health or the environment. 

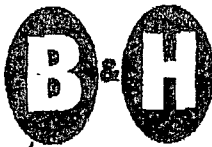
