


Pipeline pressured up and ruptured (this release occurred 0.75 miles west of the Bilhrey SWD #1). Shut pump down, isolated line.

Describe Area Affected and Cleanup Action Taken.\*

An approximate area of 50' X 50'. Repaired line and fenced off impacted area. Vertical and horizontal delineation samples will be taken and analysis run for TPH & BTEX. If initial analytical results for TPH & BTEX are under RRAL's a Final Report, C-141 will be submitted to the OCD requesting closure. If the analytical results are above the RRAL a work plan will be submitted to the OCD. Approximate chloride content of produced water is 262,000 ppm. Depth to Ground Water: >100' (approx. 272', per the NM Office of the State Engineer), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 0.
