The New Mexico Oil Conservation Division (OCD) has received the Corrective Action Plan for the BD O-17-1 Vent Site, dated September 17, 2007, and has conducted a review of the Plan. The Plan, submitted for the above-referenced site, indicates that Rice Operating Company (ROC) has substantially met the requirements of OCD Part 29 (formerly, Rule 116) for a remediation plan. Therefore, the OCD hereby conditionally approves the Corrective Action Plan for above-referenced site, dated September 17, 2007, in accordance with 19.15.29 NMAC:

ROC must backfill to surrounding grade with at least four feet of soils over the one foot thick clay liner.

ROC must backfill over the clay liner with soils that have a Benzene concentration of no more than 10 mg/Kg, a BTEX concentration no more than 50 mg/Kg and a TPH concentration no more than 500 mg/Kg. (A field soil vapor headspace measurement of 100 ppm may be substituted for a laboratory analysis of the Benzene and BTEX concentration limits.)
