COMMINGLING ORDER PLC-223

The New Mexico Oil Conservation Division (OCD) hereby authorizes Dugan Production Corporation (Dugan) to surface commingle Basin-Fruitland Coal (Gas 71629) and WAW-Fruitland Sand Pictured Cliffs (Gas 87190) Pool gas production from the spacing units and wells as detailed on Attachment 1 – all located within Townships 25 or 26 North, Range 13W, NMPM, San Juan County, New Mexico. Existing and future wells within these approved spacing units are hereby approved for surface commingling.

Continuous gas allocation meters shall be installed - at least one (1) meter measuring production from each area of common ownership or "lease". These meters shall be regularly calibrated for accuracy. Each lease's gas sales, production, and BTU values shall be calculated using data collected from allocation rate meters, total CDP sales, lost gas, fuel gas, and periodic BTU tests. Compressor fuel gas usage shall be calculated for each lease based on that lease's ratio of the total of all the allocation meters feeding that compressor.

For reporting purposes, individual well production numbers shall be calculated from the lease totals using periodic well tests.

Liquids shall not be commingled. The measurement and sales point for commingled gas may occur off lease.

NOTE: This installation shall be installed and operated in accordance with the applicable provisions of Rule 309-B of the Division Rules and Regulations and the Division "Manual for the Installation and Operation of Commingling Facilities." It is the responsibility of the producer to notify the transporter of this commingling authority.


REMARKS: The commingled production shall be delivered to the El Paso Field Services Company CDP meter located in the NW/4 SE/4 of Section 25, Township 26 North, Range 13 West, NMPM, San Juan County, New Mexico.

FURTHER: The operator shall notify the Aztec district office of the Division prior to implementation of the commingling process.
