Describe Cause of Problem and Remedial Action Taken.* During a recoating project of the El Paso Natural Gas (EPNG) Line 1100, a crack in a weld joint was discovered when the pipe coating was removed. The crack was x-rayed on 02/07/09 and it was determined that in order to safely repair the pipe, the pipeline would need to be blown down. The location of the pipe repair was 4 miles north of Highway 128 coming off the highway between mile marker 18 and 19.		
Describe Area Affected and Cleanup Action Taken.* The original volume of the release was estimated to be 13,144 MCF and this amount was included in the initial verbal notification. After blowing down the 14-mile section of pipe, the actual blow down volume was approximately 8,022 MCF. The blow down occurred at EPNG's Block Valve 3 at Mile Post 26 and Block Valve 4 at Mile Post 40 which is located approximately 5.5 miles north and 8.5 miles south of Highway 128 coming off the highway between mile marker 18 and 19. Prior to the blow down, EPNG minimized the blow down amount by taking the Eunice C Compressor Station off-line while speeding up the Pecos River and Guadalupe Compressor Stations. The suction pressure was lowered resulting in the line pressure being reduced from 740 psi to 467 psi. Repairs were made to the line prior to bringing it back in service.
