Yates Petroleum Corporation hereby seeks administrative approval pursuant to the provisions of Division Rule 104 F (2) adopted on January 18, 1996, of an unorthodox well location for all formations developed on 320-acre spacing or proration units for its John AGU Well No. 2 located 660 feet from the North and East lines of Section 14, Township 20 South, Range 24 East, NMPM, Eddy County, New Mexico. The N/2 of Section 14 will be dedicated to the well. See copy of Division Form C-102 attached hereto as Exhibit A. This well was originally drilled to the Canyon formation. Production from the well has declined to the point where it should be abandoned in the Canyon formation. Yates is proposing to reenter and recomplete the well in the Atoka and Morrow formations, Cemetery-Morrow Gas Pool.

This location is unorthodox because it is governed by the Division's statewide rules which provide for wells on 320-spacing units to be located no closer than 660 feet to the nearest side boundary of the dedicated tract nor closer than 1650 feet to the nearest end boundary of the designated drilling tract.
