

Describe Cause of Problem and Remedial Action Taken.* A contract employee was troubleshooting the 2500V/300A electric panel at the South Hobbs Unit Well #162 location. He went to turn off the disconnect on the panel and a malfunction caused the panel not to disconnect. The panel started arcing and blew a fuse on the electrical pole. A spark from the fuse reached the ground causing a small grass fire. The contractor called 911 and the Hobbs Fire Department did respond to extinguish the grass fire. No injuries due to this event. Damage only to Oxy electrical panel.

Describe Area Affected and Cleanup Action Taken.* Approximately 3 to 5 acres of grassy pasture burned before fire could be extinguished. Electrical panel will be repaired or replaced. No injuries occurred due to this event.
