Please find enclosed Commingling Application and attachments reflecting lease locations of oil wells contributing casinghead gas to proposed surface commingling order. Included are (5) Federal and (4) State wells operated by St. Mary Land and Exploration Company, as well as (3) State wells operated by Primero Operating Inc. The process will be limited to gas sales only with oil sales remaining at each lease's dedicated battery sites. All wells are producing solely in the Willow Lake; Delaware Pool (64453), which has no special pool rules and are all spaced on 40 acre spacing. The value of production should not be decreased as a result of commingling.

To satisfy the guidelines for off lease Measurement, storage, and Surface Commingling, a continuous metering device will be located at each battery where gas volumes will be metered for allocation purposes prior to commingle through a common Compressor Booster Station then on to DCP sales meter located at the Queen Lake 36 St. #1, Section 36, T-24-S, R-28-E, in Eddy County New Mexico.

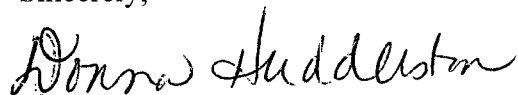

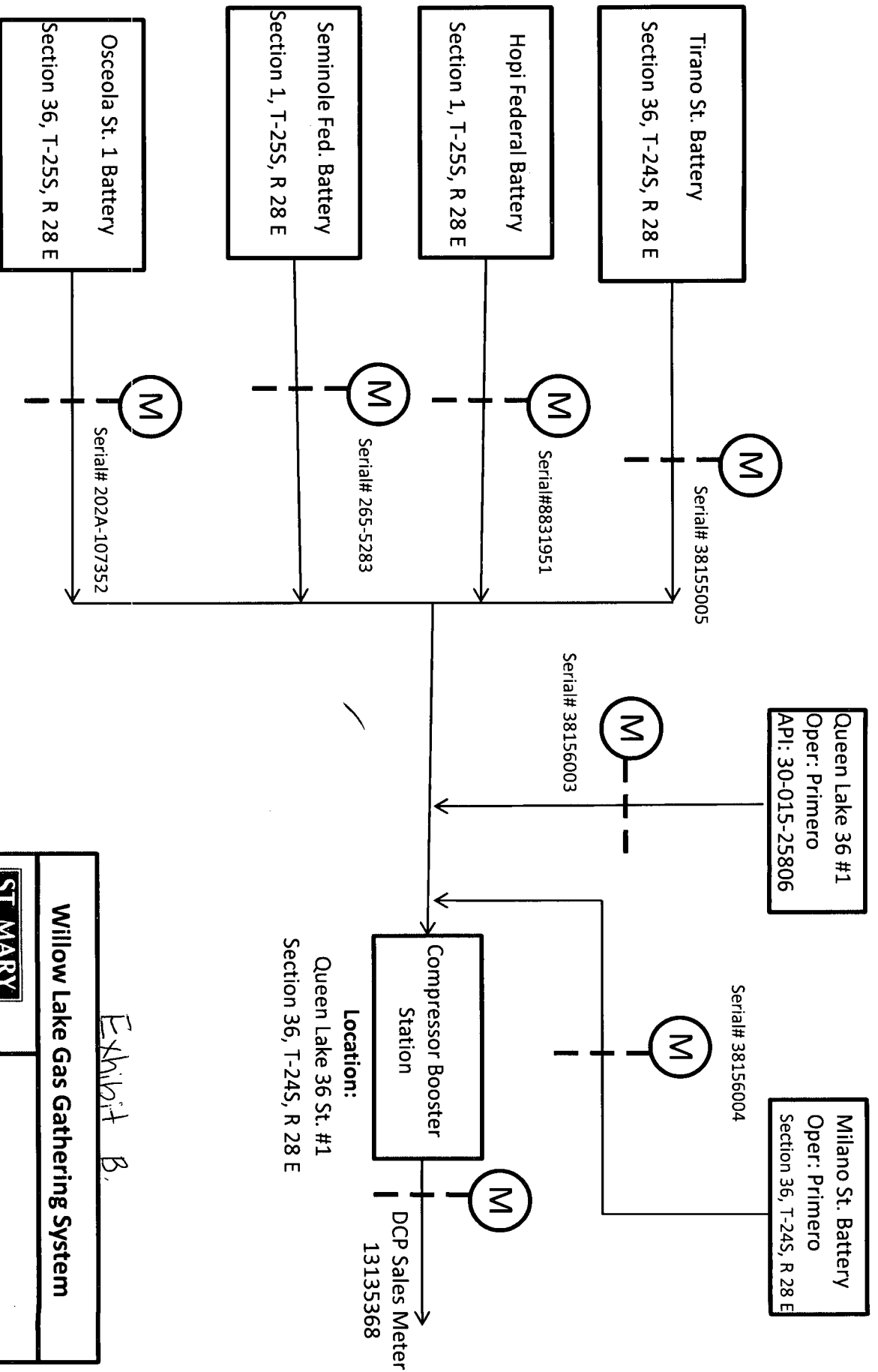
