Larson & Associates, Inc. (LAI), as consultant to John H. Hendrix Corporation (JHHC), submits this report to the New Mexico Oil Conservation Division (OCD) for centralized surface waste management facility NM-02-0021 (Facility). This report presents the operations, maintenance and monitoring results for soil and groundwater samples collected during calendar year 2008. The Facility occupies approximately 200 acres in the west half (W/2) of the southwest quarter (SW/4), and west half (W/2) of the northwest quarter (NW/4), Section 15, Township 24 South, Range 36 East, Lea County, New Mexico. The site location is presented on a topographic map in Figure 1.

Operation Background

On November 29, 2004, the OCD issued JHHC permit number NM-02-0021 to construct and operate a centralized surface waste management facility for treating non-hazardous petroleum contaminated soil resulting from spills, releases and pits from JHHC operations. The Facility consists of twelve (12) cells, numbered 1 through 12, each measuring approximately 400' x 1450' (12 acres). Each cell is subdivided into three (3) sub cells, lettered A through C, each measuring approximately 400' x 480' (4.40 acres). On January 4, 2006, the OCD approved a modification request for Cell 1 and Cell 2 to accept soil contaminated by chloride up to 1,000 milligrams per kilogram or parts per million (mg/Kg or ppm). On July 11, 2006, the OCD approved a request for Cell 3 to accept soil contaminated by chloride up to 1,000 ppm. Cell 1 is currently used for soil contaminated by chloride. Cells 1A and 1B are closed. Cell 1C is tilled once every two weeks (bi-weekly) to biodegrade residual hydrocarbons. Cells 10, 11 and Cell 12 are currently used for non-hazardous petroleum contaminated soil and tilled once every two weeks (bi-weekly) to biodegrade the petroleum hydrocarbons. Figure 2 presents a Facility drawing.

Soil samples are collected from the active cells according to a semi-annual (twice yearly) schedule approved by the OCD in the permit modification on January 4, 2006. Soil samples are collected during each semi-annual event from the vadose zone and treated (tilled) soil in the active cells. Four (4) samples are randomly collected during each event in the vadose zone from approximately 2 to 3 feet

below the base of each cell. Vadose zone samples from each semi-annual event are analyzed for benzene, toluene, ethylbenzene, xylene (BTEX) and total petroleum hydrocarbons (TPH).

In addition, vadose zone samples are analyzed for total metals (arsenic, barium, cadmium, chromium, lead, mercury, selenium and silver) and major anions and cations (total alkalinity, calcium, magnesium, potassium, sodium, chloride and sulfate). The BTEX, TPH, metals, major anions and cations are compared to background concentrations for each cell. Four (4) samples of treated (tilled) soil are randomly collected from each cell during each semi-annual event and analyzed for BTEX, TPH and chloride. The treated soil sample results are compared to action levels established in the permit, including 10 ppm for benzene, 50 ppm for BTEX and 100 ppm for TPH.

On July 1, 2005 and April 26, 2006, five (5) monitoring wells (MW-1 through MW-5) were installed at the Facility to assess groundwater conditions. The wells were drilled using conventional water rotary drilling techniques to depths ranging from approximately 160 feet (MW-2) to 195 feet (MW-5) below ground surface (bgs). The wells, except MW-5, are constructed with 2-inch schedule 40 PVC screen and approximately 20 feet of factory-slotted 0.010 inch screen. Well MW-5 is completed with 4-inch schedule 40 PVC screen and approximately 20 feet of factory-slotted 0.020 inch screen. Groundwater occurs between 148 feet bgs (MW-1) and 179 feet bgs (MW-3). Groundwater samples are collected from the monitoring wells on a semi-annual (twice yearly) schedule and analyzed for BTEX, metals, major anions, cations and total dissolved solids (TDS).

During 2008, the Facility accepted approximately 21,604 cubic yards of contaminated soil from JHHC operations. This soil was placed in Cells 1, 10 and 11. Appendix A presents quarterly summaries for soil hauled to the Facility during the reporting period.

Background Soil Samples

On November 29, 2004, LAI personnel collected a background sample (JHBH-1) prior to construction of the Facility. The sample was collected from approximately 2 to 3 feet below the native ground surface near the center of the Facility. On April 27, 2007, background samples were collected from approximately 2 to 3 feet below sub cells A, B and C in Cell 1 and Cell 12. Background samples for Cell 11 (sub cells A and B) and Cell 10 (sub cells A, B and C) were collected on January 7, 2008. On October 15, 2007, background samples were collected from approximately 2 to 3 feet below sub cell C in Cell 11. The samples were collected using direct-push technology and dual-tube sampling system. The dual tube system prevents overlying soil from caving thus minimizing the possibility of cross-contamination between the treated and vadose samples. The core barrel is equipped with dedicated polyethylene liners to reduce cross-contamination between samples. Samples were placed in pre-cleaned four (4) ounce jars, properly labeled and placed on ice upon collection. The samples were shipped via LoneStar Overnight, under chain of custody, to DHL Analytical (DHL), located at 2300 Double Creek Drive, in Round Rock, Texas.

The background samples were analyzed for the following constituents:

- Benzene, Toluene, Ethyl benzene and Total Xylenes (BTEX) by EPA method SW8021B;
- Total Petroleum Hydrocarbons (TPH) by EPA method SW8015 for gasoline range organics (GRO) and diesel range organics (DRO);
- Metals (Arsenic, Barium, Cadmium, Calcium, Chromium, Lead, Magnesium, Potassium, Selenium, Sodium and Silver) by EPA method SW6020;
- Mercury by EPA method SW7470A,
- Anions (Chloride and Sulfate) by EPA method 300, and
- Alkalinity by EPA method 310.1.

Tables 1, 2, 3 and 4 present background and vadose sample results for BTEX, TPH, metals and general chemistry (major anions and cations), respectively. Appendix B presents the analytical reports.

Vadose Zone Samples

The first semi-annual vadose zone samples were collected on March 20, 2008. The second semi-annual vadose zone samples were collected on October 6 and 7, 2008. Samples were collected at four (4) randomly selected locations from approximately 2 to 3 feet below cells Cell 10, Cell 11 and Cell 12. The samples were analyzed for BTEX, TPH, metals, general chemistry (major anions and cations). Table 1 presents a summary of the BTEX analysis. Table 2 presents a summary of the TPH analysis. Table 3 presents a summary of the metals analysis. Table 4 presents a summary of the general chemistry analysis. Appendix B presents the laboratory reports.

No BTEX constituents were reported in the vadose zone samples from the first and second semi-annual events from Cell 1, Cell 10, Cell 11 and Cell 12. No TPH was reported in the treatment zone samples from Cell 1, Cell 10, Cell 11 and Cell 12 during the first semi-annual treatment zone event. TPH was reported above the method detection limits in the second semi-annual vadose zone samples from Cell 12C (16.6 ppm and 67.1 ppm). The TPH results were above the background concentration, but may be due to incidental contribution from the treated soil during sample collection.

Total metal concentrations in treatment zone samples from the first and second semi-annual events were consistent with the background concentrations.

Alkalinity, sodium, chloride and sulfate in the vadose zone samples from Cell 1A and Cell 11B were above background concentrations and may be attributed to natural concentration variation or incidental contribution from the treated soil during sample collection. The remaining samples, except alkalinity and calcium in the samples from Cell 11C and Cell 12C, were consistent with the background concentrations. Sodium and sulfate were consistently above the background values for Cell 1A and Cell 1B.

Treated (Tilled) Soil Samples

Samples of treated (tilled) soil were collected on March 13, 2008 from Cells 1, 11 and 12 for the first semi-annual event. Samples were collected from Cells 1, 10, 11 and 12 on October 6 and October 7, 2008, for the second semi-annual event. Four composite samples were collected from each active cell,

including Cells 1, 11 and 12. One composite sample was also collected from Cell 10C on October, 2008. The samples were collected between 0-1 feet of the tilled zone, placed in pre-cleaned 4-ounce jars, properly labeled and placed on ice upon collection. The samples collected on March 13, 2008 were shipped via LoneStar Overnight, under chain of custody to DHL. The samples were analyzed for BTEX, TPH and chloride. Table 5 presents a summary of the BTEX analyses. Samples collected on October 6 and October 7, 2008 were hand delivered under chain of custody to Environmental Laboratory of Texas (ELOT), located in Odessa, Texas. Table 6 presents a summary of the TPH and chloride analysis. Appendix B presents the laboratory reports.

No BTEX was reported in the treated soil from Cells 1, 10 and 12. Total Xylenes was reported in the samples from Cell 11B (0.0533 ppm and 0.0661 ppm). The Total BTEX detected was below the 50 ppm action level. TPH was below 100 ppm in the treated soil from Cell 1A. TPH exceeded 100 ppm in treated soil from Cell 1B, Cell 10C, Cell 11A, Cell 11B, Cell 11C, Cell 12A, Cell 12B and Cell 12C. Chloride ranged from less than the method detection limit to a maximum concentration of 1,170 ppm in Cell 11B.

Depth-to-Groundwater and Groundwater Flow

On May 28 and October 7, 2008, LAI personnel measured depth-to-groundwater in monitoring wells MW-1 through MW-5. The measurements were recorded at the top of the PVC well casing which had been surveyed to mean sea level (MSL) by Piper Surveying, Inc., a New Mexico registered professional land surveyor. On May 28, 2008, the groundwater elevation ranged from 3,213.01 feet above MSL at well MW-4 (up gradient) to 3,207.60 feet above MSL at well MW-2 (down gradient). On October 7, 2008, the groundwater elevation ranged from 3,212.93 feet above MSL at well MW-4 (up gradient) to 3,207.53 feet above MSL at well MW-2 (down gradient). The ground water flow direction was from north-northeast to south-southwest at an approximate gradient of 0.001 feet per foot. Figure 3 and Figure 4 present groundwater potentiometric maps for May 28 and October 7, 2008, respectively. Table 8 presents a summary of the well details and depth-to-groundwater measurements.

Groundwater Samples

On May 28, October 7 and October 8, 2008, LAI personnel collected ground water samples from monitoring wells MW-1 through MW-5. The samples were collected after removing approximately 3 casing volumes of water each well by hand bailing with dedicated disposable polyethylene bailers. The samples were carefully poured into appropriate sample containers with preservatives provided by the laboratory. The sample containers were properly labeled, placed on ice upon collection and shipped via LoneStar Overnight and under chain of custody to DHL Laboratories, located in Round Rock, Texas or hand delivered to ELOT, located in Odessa, Texas. The samples were analyzed for the following parameters: BTEX, metals, anions, alkalinity and TDS. The metals samples were filtered in the laboratory using 0.45-micron disposable filters. Table 9 presents a summary of the BTEX analysis. Table 10 presents a summary of the general chemistry analysis. Table 11 presents a summary of the dissolved metals analysis. Appendix B presents the laboratory reports.

The sample results were below detection limits for the BTEX constituents. The results for metals analysis were below the New Mexico Water Quality Control Commission (NMWQCC) human health standards. The sample results for chloride and TDS from well MW-1 were above the NMWQCC domestic water quality thresholds of 250 ppm and 1,000 ppm, respectively, but are consistent with

previous results reported for the wells. The chloride for sample MW-5 collected on October 8, 2008, was above the NMWQCC threshold of 250 ppm. Previous results for MW-5 were below the NMWQCC threshold. The remaining cations, anions and alkalinity results were within normal variations.

Recommendations

Soil samples will be collected from the treatment (tilled) zone in the active Cell 1C, Cells 10, 11 and 12 during the first semi-annual of 2009 to verify the October 2008 samples results. Samples will be collected at four (4) randomly selected locations in Cell 10, Cell 11 and Cell 12 at depths of approximately 2 to 3 feet below the cells. Two (2) samples will be collected at random locations from Cell 1C at depths of approximately 2 to 3 feet below the cell. All samples will be analyzed for BTEX, TPH, metals, anions and alkalinity.

Tilling in Cell 1A and Cell1B has been discontinued since laboratory results show benzene, BTEX and TPH below the permitted limits of 10 ppm, 50 ppm and 100 ppm, respectively.

Tilling will continue in Cells 10, 11, 12 and Cell 1C to further degrade the petroleum hydrocarbons. Samples of treated (tilled) soil will be collected from Cell 1C, Cell 10, Cell 11 and Cell 12 during the first semi-annual of 2009 and analyzed for BTEX and TPH to verify the October 2008 samples results and assess tilling requirements.

Analyses will be reported to the OCD within 45 days after receipt of the laboratory reports.




Figure 1 - Topographic Map





Figure 3 - Groundwater Potentiometric Surface Map, May 28, 2008


