

Describe Cause of Problem and Remedial Action Taken.*

High winds caused sign at lease to fall over and hit release valve, cracking the valve open. Spill affected a 30' X 10' area on location. NMOCD(Jeff Leking) was contacted 4/30/09 at 8:50 am, and advised of soil test results taken from the spill site. Remediation efforts will consist of removal of top 3" of impacted soil, to be hauled to Sundance Services for disposal, and backfilled with clean, like, materials, as per the conversation with NMOCD Representative Leking. Copies of lab results will be sent to NMOCD with the initial C-141.

Remediate to NMOCD Requirements. Listed Above.
