Conoco, Inc just completed the drilling of this well in September, 1999. The objective was the North Hardy Strawn pool. Unfortunately there was no economic reason to perforate the Strawn however pipe was set based on log analysis of the Abc. Conoco applied for and was granted a NSL Order # 4365 for the Southeast Monument Abo (Oil). Since that time the NMOCD in Hobbs has said that this well needs to be in the South Skaggs Abo pool (Oil). The reason Conoco put this well in the SE Monument pool to begin with is that based on the log interpretations the Abo section looked more like the wells in the Monument pool located NW of the #136. It was assumed that the well would behave much like the wells to the NW and have a very high GOR. The well has since been perforated and the tests indicate that the Abo is not going to perform like the SE Monument pool wells. Therefore Conoco would like to amend the NSL Order # 4365 to be the South Skaggs Abo pool (Oil). (See attached amended C-102)


This well is located 1980 FSL & 1090' FWL in Section 25, T-20-S, R-37-E, Lea County, NM. The well is non-standard in a 40-acre tract because it is 1090' FWL and that is 100' too far west to be a standard location. The N ½ of the S ½, and the N ½ of Section 25 is Federal lease # 031696A. The offsetting section to the west, Section 26 is also Federal Lease # 031696. The SW ¼ of the SW ¼ of Section 25 is a 40 acre State Lease # B-230 100% owned 100% by Chevron, our partners. The SE ¼ of the SW ¼ of Section 25 is a 40 acre state Lease # E-1402 operated by Conoco. Upon completion in the Tubb, and subsequent production, eventually Conoco plans on Downhole Commingling the Abo and Tubb. (See attached Sundry)

Conoco, Inc. is the only offset operator. Conoco, Inc. respectfully requests that their application be approved to provide them the opportunity to utilize the #136 wellbore profitably. 


