

Re: Application for a Nonstandard Proration Unit to be assigned Sinclair's Ida White Well No. 1 in the Eumont Gas Pool, Lea County, New Mexico.

Gentlemen:

Sinclair Oil & Gas Company wishes to make this application for an Administrative Order under Rule R-520 which will establish a Nonstandard Gas Proration Unit of 80 acres in the Eumont Gas Pool to be assigned to subject well. We are making this application in compliance with the instructions contained in your notice of reclassification of subject well dated March 8, 1955.

In this connection Sinclair wishes to state:

1. Sinclair is the Operator of the Ida White Well No. 1 which is located in the NE/4 of the SE/4 of Section 35, T-20-S, R-36-E, Lea County, New Mexico.
2. The Nonstandard Proration Unit Sinclair seeks to have assigned to subject well consists of Sinclair's Ida White lease which contains 80 acres and is located in the N/2 of the SE/4 of said Section 35. Subject well is located 330 feet from South and 330 feet from East lines of this Unit, and currently has a 40 acre oil allowable in the Eunice Oil Pool.
3. The proposed Unit consists of contiguous quarter-quarter sections and is wholly contained in a single governmental section. The length or width of the proposed Unit does not exceed 5280 feet.
4. All of the acreage within the proposed Unit may reasonably be presumed productive of gas.
5. Both the royalty and leasehold interests are common under this proposed Unit.
6. Sinclair believes that the granting of this application is in the interest of conservation and the protection of correlative rights.


