Dear Sir:

Reference is made to your letter of May 23, 1955, pertaining to overproduction of gas from the above-captioned well. The Commission has delayed the actual reclassification of this well until June 1, 1955. On that date your well will be carried as a gas well in the Jalmat Gas Pool and will be removed from the Oil Proration Schedule (Cooper-Jal Pool). The gas allowable to be assigned this well is to be based on your 120-acre proration unit.

With regard to your anticipated overproduction of this well due to the possibility of the well logging-off with water, the Commission will not order the well shut-in, due to overproduction, any time before January 1, 1956. If on that date the well has a considerable amount of overproduction it may be necessary for us to take some other action. However, until that time you are authorized to produce the well in the manner you deem advisable.

For your information, in order for you to run the oil produced by this well it will be necessary for you to request a supplementary oil allowable from our proration office at Hobbs. Please contact our proration manager, Mr. A. L. Porter at Hobbs, for instructions.

Dear Sir:

Under the provisions of Commission Order No. R-520, Rule 5 (b), delegating the Secretary of the Commission authority to grant exceptions to the requirements of Rule 5 (a) without notice and hearing for a non-standard gas proration unit, Jerry Covington hereby applies for an exception to this rule for Federal No. 2, Jalmat Field.

In support of the above application, the following data are furnished:

Federal No. 2 is located 1980' from south line and 660' from west line of Section 31, T-25-S, R-37-E. It was originally completed as a Cooper-Jal Field well in March, 1952. It is producing from the Yates sand through perforations at 2884-2978 and 3067-3077 feet.

With regard to the exception to Rule No. 5 (a), I wish to state the following:

- 1) That the proposed non-standard gas proration unit of 120 acres, consisting of lots 3 and 4 and the NE/4 of the SW/4 Section 31, T-25-S, R-37-E, is 3/4 of a standard governmental quarter section.
- 2) That the proposed non-standard gas proration unit lies wholly within a single governmental section.
- 3) That the entire proposed non-standard gas proration unit may reasonably be presumed to be productive of gas.
- 4) That the length or width of the proposed non-standard gas proration unit does not exceed 5280'.
- 5) That the entire proposed non-standard gas proration unit lies within the horizontal limits of the Jalmat Gas Pool.

- 6) That by copy of this letter of application all operators owning interest in the section in which the non-standard gas proration unit is situated and which acreage is not included in said non-standard gas proration unit and all operators owning interest within 1500' of the well have been notified by registered mail of this application.
