Gentlemen:

By this letter of application Amerada Petroleum Corporation wishes to
state the following:

- (a) That Amerada Petroleum Corporation requested by letter of application dated August 8, 1955, permission to dually complete the Falby No. 3 located 1980 ft. FSL and 1916 ft. FWL of Section 19, Township 24-S, Range 37-E, Lea County, New Mexico.
- (b) That the applicant proposes to assign this well a non-standard gas proration unit consisting of 40 acres which is the NE/4 of the SW/4 of Section 19, Township 24-S, Range 37-E, Lea County, New Mexico.
- (c) That the proposed non-standard gas proration unit lies wholly within a single governmental section.
- (d) That the proposed non-standard gas proration unit may reasonably be presumed to be productive of gas.
- (e) That in compliance with the Commission Order No. R-640, Rule (8), this 40 acres is not simultaneously dedicated to an oil well in the Jalmat Gas Pool.
- (f) That by copy of this letter of application by registered mail all offset operators are notified.

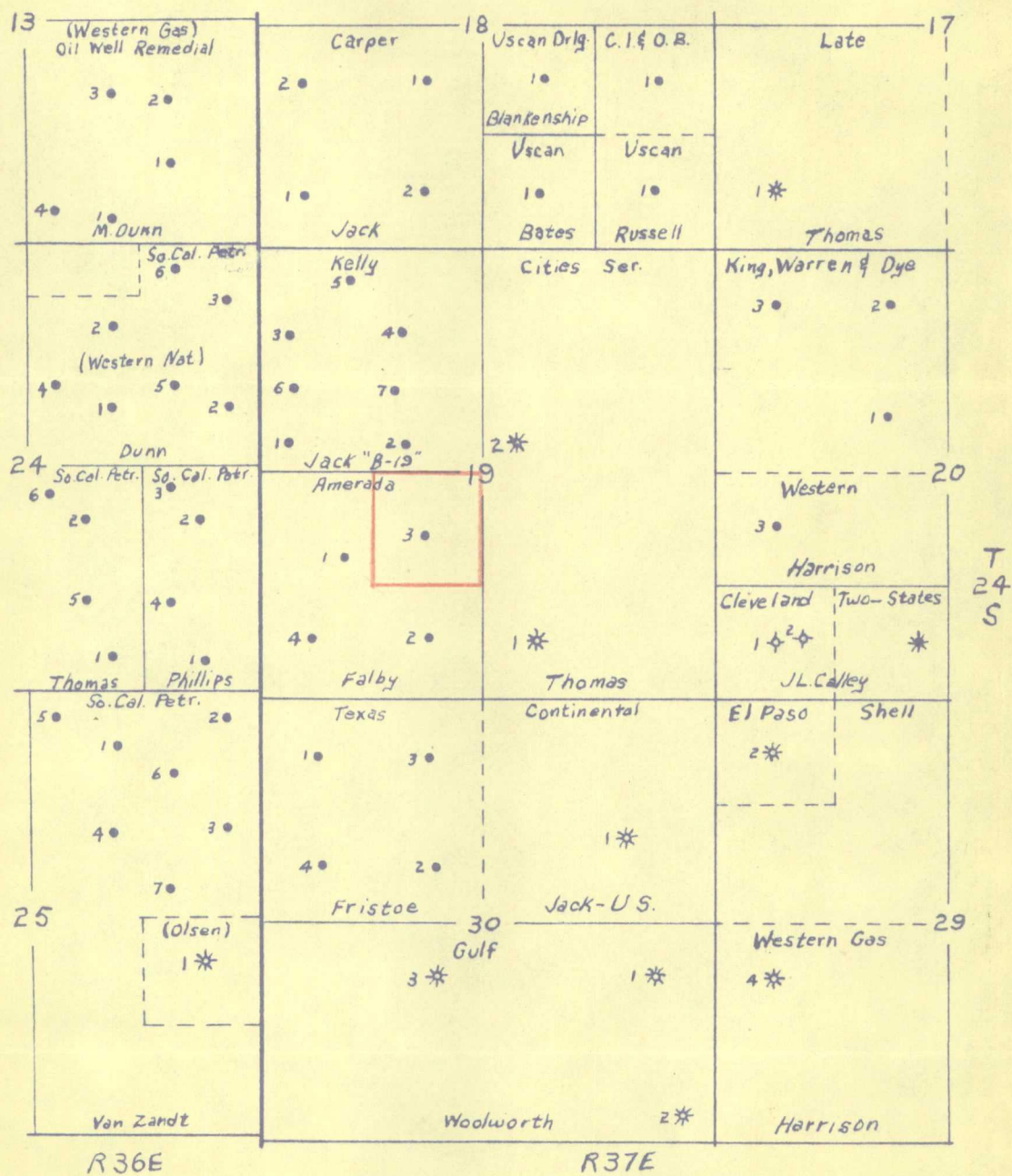
