Gentlemen:

By letter dated August 9, 1955, from Mr. A. L. Porter, Jr., we were notified that their records indicated that the above captioned well was producing from the horizontal and vertical limits of the Jalmat Pool and since the gas-oil ratio exceeded 100,000 to 1, that we should make application to this office for a non-standard gas proration unit so that the well might be operated as a Jalmat Gas Well. We have reviewed our files and agree that the well should be reclassified and therefore present the following information to support our request for a non-standard gas proration unit.

1. Well name and location - Grace B. Hadfield No. 1, 1980 feet from the South and East lines of Section 21, T-25-S, R-37-E, Lea County, New Mexico.
2. Description of non-standard gas proration unit - the non-standard unit shall consist of 40 acres described as the NW/4 of the SE/4 of Section 21, T-25-S, R-37-E, Lea County, New Mexico.
3. The non-standard proration unit consists of contiguous acreage in a single quarter-quarter section.
4. The non-standard gas proration unit lies wholly within Section 21, T-25-S, R-37-E, Lea County, New Mexico.
5. The entire non-standard gas proration unit, that is, the NE/4 of the SE/4 Section 21, may reasonably be presumed to be productive of gas.
6. The length or width of the non-standard gas unit does not exceed 5,280 feet.

7. All operators owning interest within 1500 feet of the well to which gas proration unit is proposed, have been notified by registered mail.

We have attached a gas well plat which shows the non-standard proration unit to be dedicated to subject well. We have also attached a copy of our letter to all offset operators advising them of this application.

We would like to request administrative approval of this application under Rule 5-b of the Rules and Regulations for the Jalmat Gas Pool.

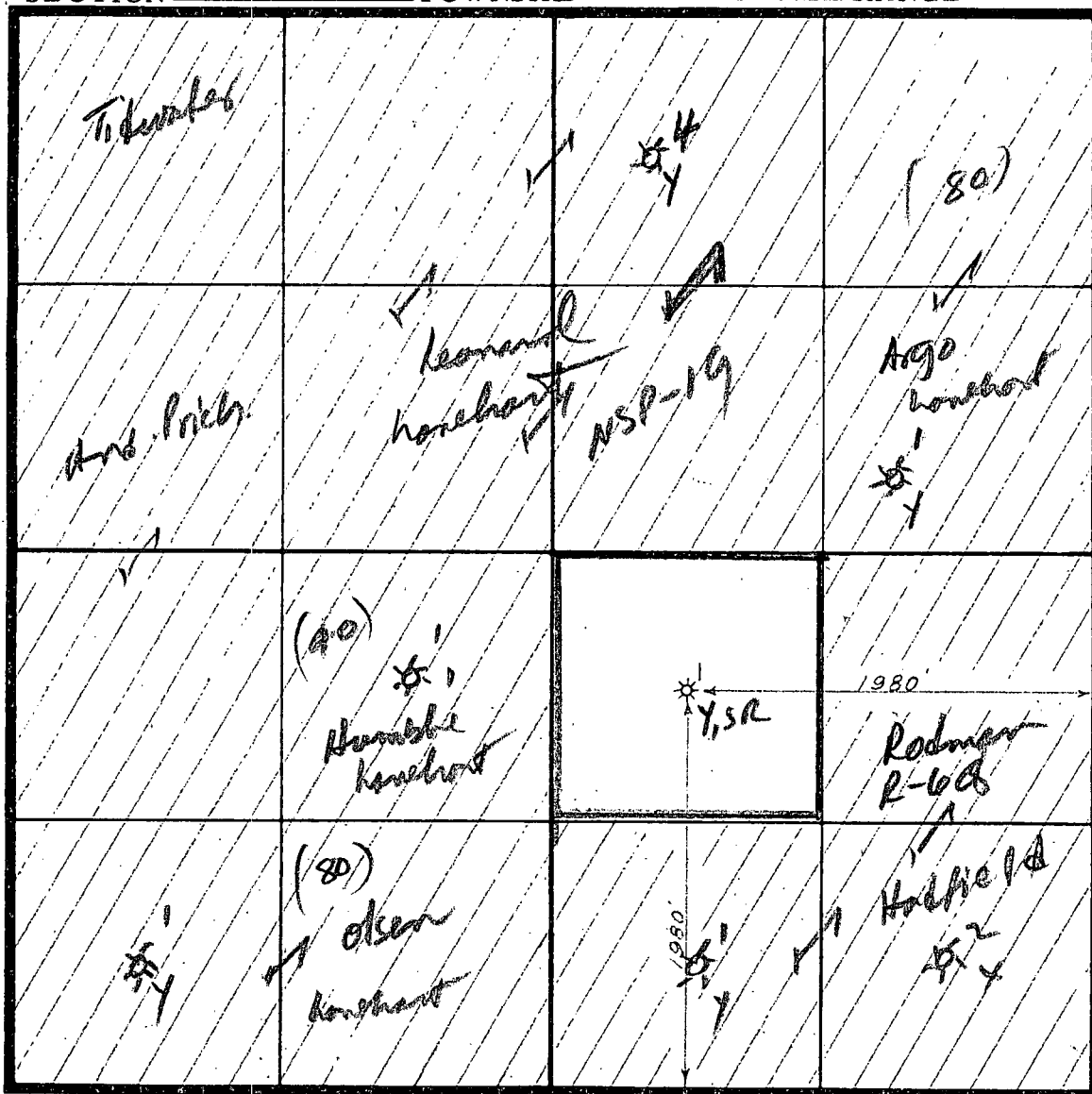

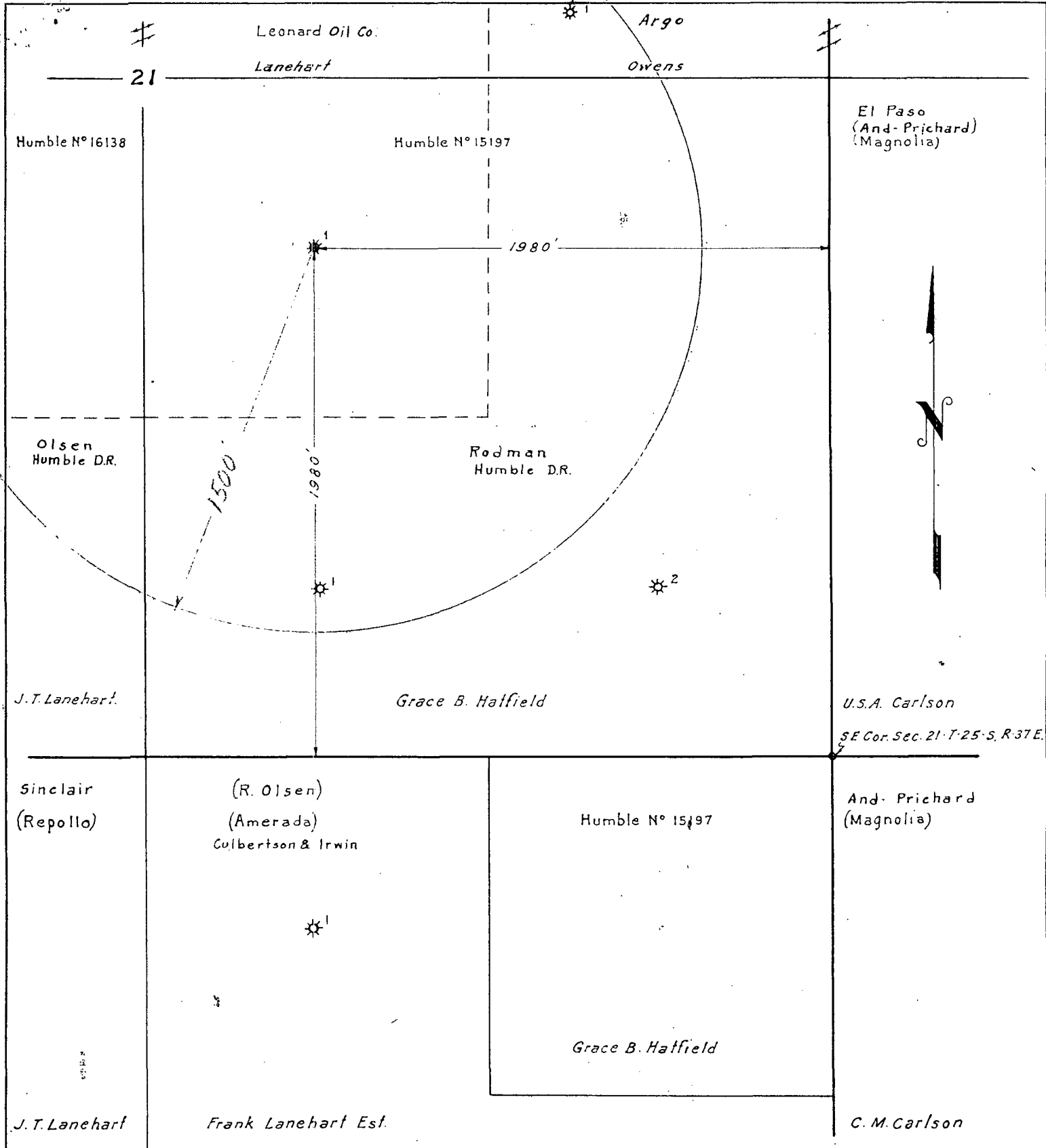

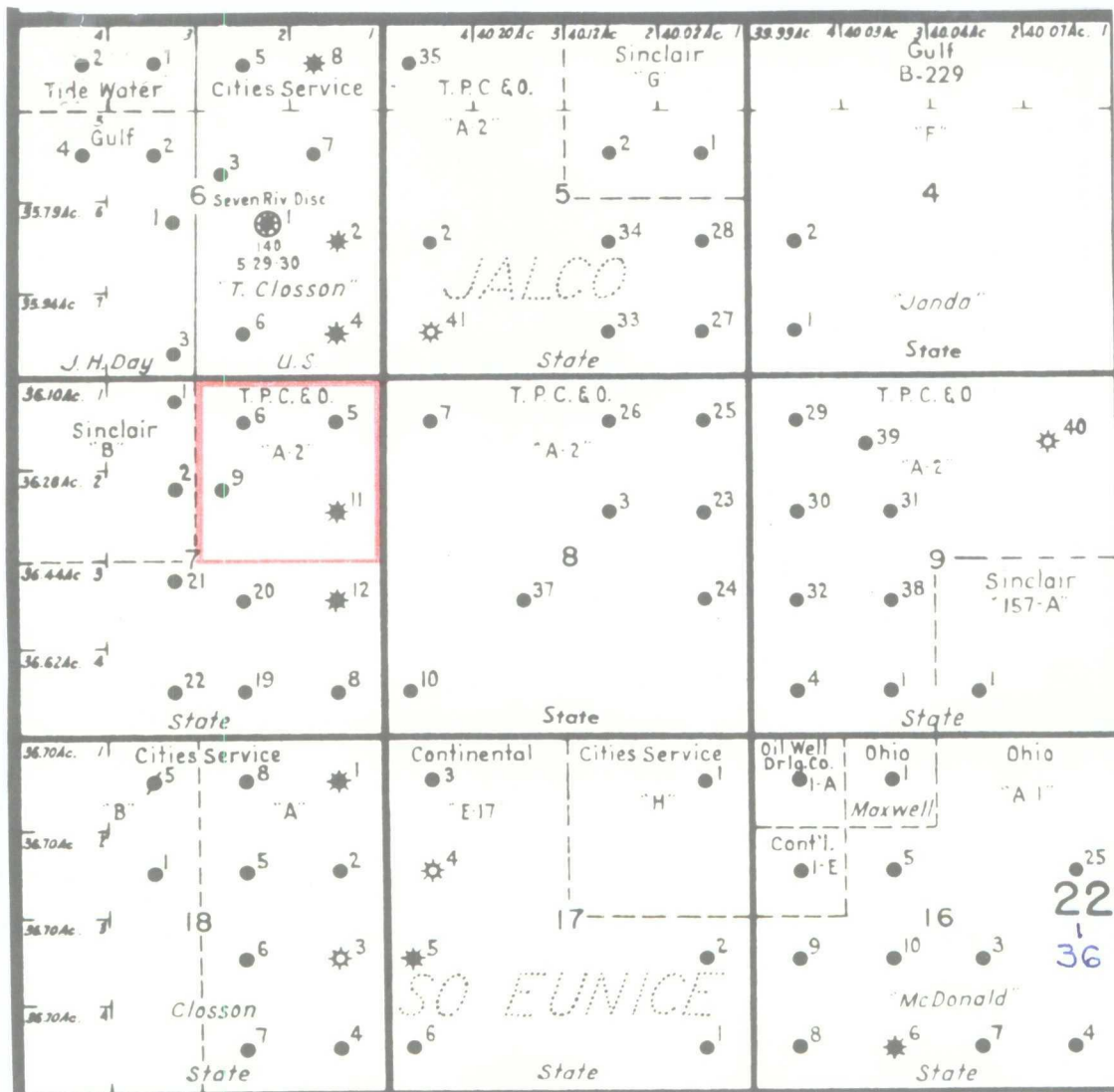
