Gentlemen:

Cities Service Oil Company hereby makes application for approval of a non-standard gas proration unit comprising SW/4 of Section 2-22S-36E, Lea County, New Mexico, and in support thereof states the following facts.

1. State "N" #5 is located 660' from the South Line, 660' from the West Line of Section 2-22S-36E, Lea County, New Mexico, and was completed May 27, 1956, as a Eumont Gas Well.
2. An exception to Rule 5(a) Order R-520 is requested in order to assign the State "N" No. 5 a 160 non-standard gas proration unit. This non-standard gas proration unit consists of contiguous quarter/quarter sections within a single governmental section and the entire area may reasonably be presumed to be productive of gas.
3. The attached plat indicates the acreage to be assigned to this well and the offset ownership.
4. All operators owning interests in Section 2 and within 1800' of the State "N" No. 5 have been furnished copies of this request by registered mail.

In view of the existence of the above facts herein stated and compliance with the provisions of Rule 5(a) of the Oil Conservation Commission's Order No. R-520, Cities Service Oil Company requests the Commission approve the above described non-standard gas proration unit.

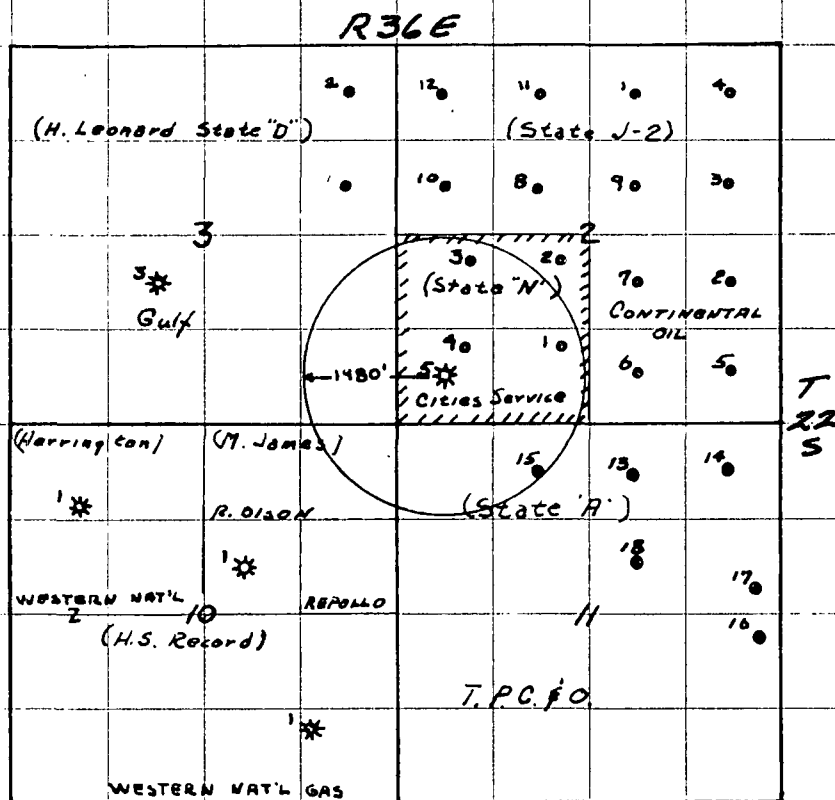
