El Paso Natural Gas Company respectfully requests Administrative Approval under the provisions of Rule 5(b) of Order No. R-520 for a Non-Standard Gas Proration Unit of 160 acres, more or less, consisting of the NW/4 of Section 27, Township 25 South, Range 37 East, N.M.P.M., Jalmat Gas Pool, Lea County, New Mexico, and in support thereof states the following facts:

- 1. That R. Olsen completed the R. Olsen Harrison Federal #2 Well on June 8, 1956. That said well is located 660 feet from the North and West lines of Section 27, Township 25 South, Range 37 East, N.M.P.M. That this well was drilled to a total depth of 3542 feet and was plugged back to 3300 feet and was completed as a gas well in the Jalmat Gas Pool with an initial potential of 5,800 MCF absolute open flow.
- That by Bill of Sale dated May 25, 1956, R. Olsen sold this well to El Paso Natural Gas Company.
- That El Paso Natural Gas Company holds the Gas Operating rights under the NW/4 of said Section 27.
