Amended Administrative Order NSP-315

Dear Mr. Steward:

Reference is made to your application dated July 9, 1990 to reduce the acreage of the existing 160-acre non-standard gas spacing and proration unit in the Eumont Gas Pool comprising the N/2 N/2 of Section 29, Township 20 South, Range 37 East, NMPM, Lea County, New Mexico, which was approved by the original Division Administrative Order NSP-315, dated September 10, 1956 and reconfirmed by Division Order No. R-6276, dated February 26, 1980, to a 120-acre non-standard gas spacing and proration unit consisting of the NW/4 NE/4 and N/2 NW/4 of said Section 29. By Division Order No. R-6276-A, dated January 9, 1984, said 160-acre unit was authorized to be simultaneously dedicated to the A. B. Reeves Well Nos. 6 and 7, located in Units A and C, respectively.

It is our understanding that such rededication is necessary due to the reclassification of the A. B. Reeves No. 6, located 660 feet from the North line and 610 feet from the East line (Unit A) of said Section 29, form a Eumont Gas well to a Eumont Oil well effective June 1, 1990.

By authority granted me under the provisions of Rule 2(a)4 of the Special Rules and Regulations for the Eumont Gas Pool, as promulgated by Division Order No. R-8170, as amended, the following described 120-acre non-standard gas spacing and proration unit is hereby approved:

LEA COUNTY, NEW MEXICO <u>TOWNSHIP 20 SOUTH, RANGE 37 EAST</u> Section 29: NW/4 NE/4 and N/2 NW/4. Amended Administrative Order NSP-315 Doyle Hartman August 8, 1990 Page 2

Said unit is to be dedicated to the existing A. B. Reeves Well No. 7 located at a previously approved unorthodox gas well location 990 feet from the North line and 2310 feet from the West line (Unit C) of said Section 29.

Also, Division Administrative Order NSP-310 in its entirety and any provisions of said Order Nos. R-6276 and R-6276-A not pertinent to the immediate administrative order shall be placed in abeyance until further notice.
