NOVA Safety and Environmental (NOVA), on behalf of Plains Marketing, L.P. (Plains) respectfully submits the following notification of plugging and abandonment of monitor wells at the Plains Monument 11 leak site, located in the SE ¼, NE ¼, Section 30, T-19-S, R-37-E in Lea County, NM.

On June 9, 2009, six (6) monitor wells were plugged and abandoned at the Plains Monument 11 site. Please reference your letter to Mr. Jason Henry of Plains Marketing L.P. dated April 20, 2009 regarding authorization to plug and abandon these wells.

The monitor wells were plugged and abandoned by Straub Corporation, Inc (Straub) of Stanton, Texas, a licensed water well driller in the State of New Mexico. The monitor wells were plugged utilizing guidelines set forth by the office of the New Mexico State Engineer. Straub removed and disposed of the monitor well cover, vault, and the remains of the concrete pad.

Monitor wells MW-1 through MW-6 were each filled with approximately 3 bags of bentonite hole plug to a depth of approximately two (2) feet bgs and hydrated with properly hydrated with water. Concrete was placed from approximately two (2) feet bgs to the surface and hydrated with water. Topsoil was placed above the former monitor well to complete the procedure.

The former monitor well locations are as follows:

- MW-1, 32 degrees, 38.120" N, 103 degrees, 16.965" W
- MW-2, 32 degrees, 38.137" N, 103 degrees, 16.973" W
- MW-3, 32 degrees, 38.123" N, 103 degrees, 16.982" W
- MW-4, 32 degrees, 38.131" N, 103 degrees, 16.999" W
- MW-5, 32 degrees, 38.138" N, 103 degrees, 16.999" W

- MW-6, 32 degrees, 38.122" N, 103 degrees, 16.999" W

Plains has completed the approved plugging and abandonment of the above referenced monitor wells as directed by the New Mexico Oil Conservation Division (NMOCD). Plains will continue to gauge and sample the remaining monitor wells at the site.

In the future, Plains may make addition requests to the NMOCD for plugging and abandonment of monitor well(s) at this site, if warranted.
