Ladies and gentlemen:

Attached is an application requesting approval of a third well in the above well unit. The N $\frac{1}{2}$ §7 is a previously approved non-standard well unit in the Eumont Gas Pool, with two existing wells in the NE $\frac{1}{4}$ §7. The well unit and simultaneous dedication were approved before the pool rules for the Eumont Gas Pool were amended in 2001 (Order No. R-8170-P). Under Rule 3(C), one well per is allowed per 160 acres, and two wells are allowed on a 320 acre unit. An exception requires notice to offsetting operators.

Strictly speaking, the application violates Rule 3(C). However, it appears that existing nonstandard units and well densities were grandfathered-in. As a result, this application has been filed **without notice to offsets** because it is the first well in the NW¹/4 §7. Please let us know if this interpretation is correct.


Dear Mr. Williams:

It was recently called to my attention that Division Administrative Order NSL-378-A(SD), dated August 22, 1994, which authorized Amerada Hess Corporation to drill its H. L. Houston Gas Com Well No. 4 (API No. 30-025-32572) at an unorthodox infill gas well location 1723 feet from the North line and 1310 feet from the East line (Unit H) of Section 7, Township 21 South, Range 36 East, NMPM, Lea County, New Mexico, within an existing non-standard 320-acre gas spacing and proration unit ("GPU") for the Eumont Gas Pool comprising the N/2 of said Section 7 (approved by Division Administrative Order NSP-378, dated July 27, 1957) that already had dedicated thereon the H. L. Houston Gas Com Well No. 3 (API No. 30-025-04541), located at a standard gas well location 660 feet from the North line and 1980 feet from the East line (Unit B) of said Section 7, was assigned an incorrect "Administrative Order No.", or designation.
