Gentlemen:

This is Shell Oil Company's application for a 120-acre Non-Standard Gas Proration Unit to be dedicated to Shell Argo A No. 5, Blinebry (Gas) Field, Lea County, New Mexico. As shown on the attached plat, this well is located 1980 feet from north line and 2130 feet from west line of Section 22, T-21-S, R-37-E, Lea County, New Mexico.

Shell Argo A No. 5 was completed as a Blinebry (Gas) producer in February 1953. Currently, 100 acres (outlined in red on the attached plat) are dedicated to this well. We are requesting a reduction in unit size because of the recent recompletion of Shell Argo A No. 10 as a Blinebry (Oil) producer.
