Gentlemen:

Continental Oil Company respectfully requests administrative approval under the provisions of Rule 5 (c) of the Special Rules and Regulations for the Eumont Gas Pool of Order R-1670 for the formation of a 40-acre non-standard gas proration unit consisting of the NW/4 of the NW/4 of Section 12, Township 20 South, Range 37 East, for its Skaggs B-12 No. 2 well located 660 feet from the north line and 610 feet from the west line of Section 12, Township 20 South, Range 37 East, Lea County, New Mexico, in the Eumont Gas Pool.


In support of this request we should like to point out that the proposed unit conforms with the requirements of said Rule 5 (c) in all respects as follows:

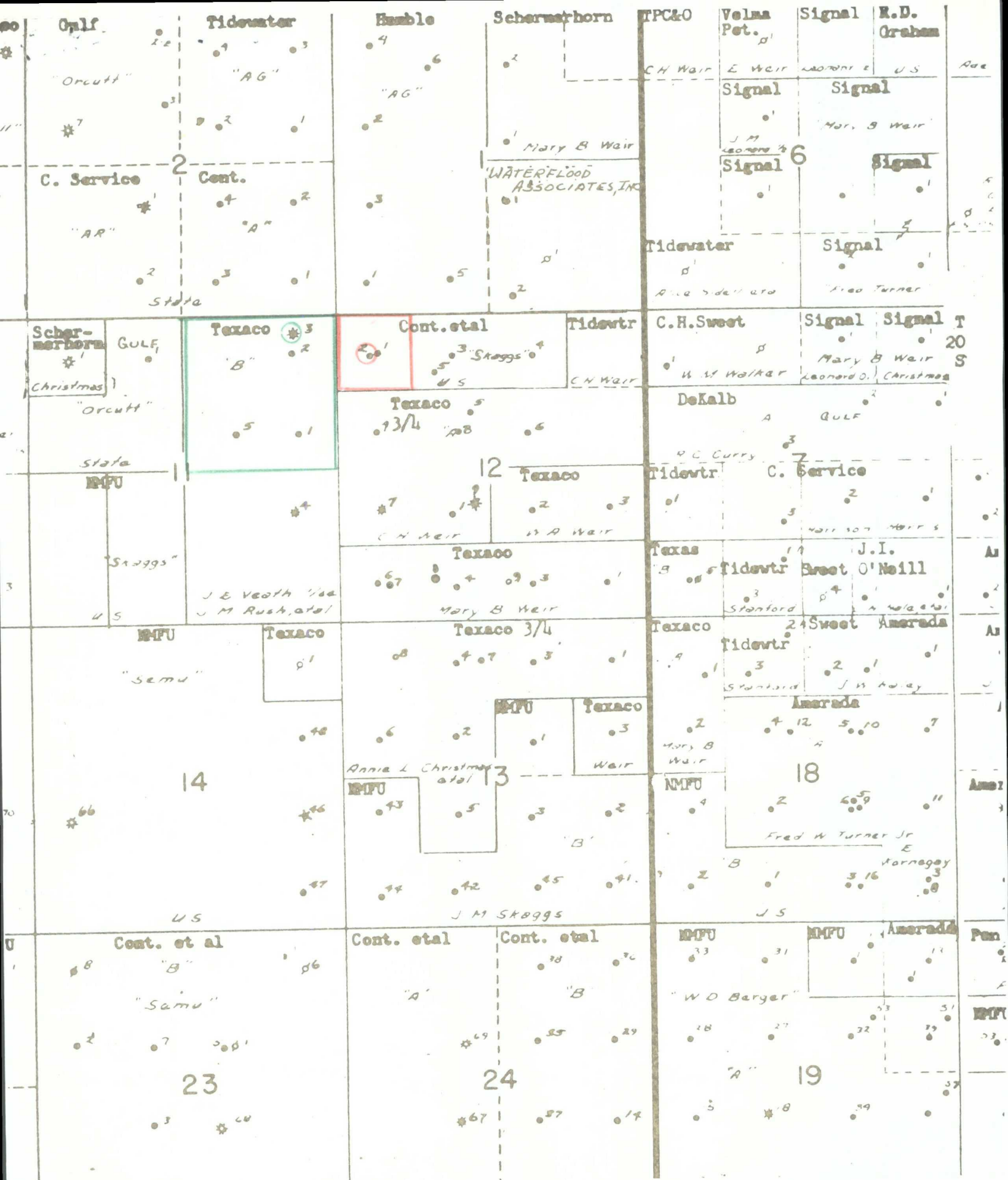
1. Said proposed non-standard gas proration unit consists of a single quarter-quarter section.
2. Said proposed non-standard gas proration unit lies wholly within a single governmental section.
3. The entire proposed non-standard gas proration unit may be reasonably presumed to be productive of gas.
4. The length or width of said unit does not exceed 5,280 feet.
5. Copies of this application have been furnished this date by registered mail to all operators within the same section and/or within 1,500 feet of said well, as required by the provisions of said Rule 5 (c).

A plat is attached hereto showing to the best of our knowledge and belief the proposed unit, the location of the No. 2 well and other wells on the lease, offset wells and ownership thereof.

The granting of this application is in the interest of preventing waste and the protection of correlative rights.

In view of the facts set out herein it is respectfully requested that the Commission enter an order approving the non-standard gas proration unit for Continental Oil Company's Skaggs B-12 No. 2 well as described above.
