

Dear Sir or Madam:

Energen Resources Corporation (Energen) hereby requests Administrative Approval for an Unorthodox Location of its existing Jicarilla 119N 8A to now encompass the Tapicito Pictured Cliffs Formation.

The well bore is located 800' FNL & 535' FWL of Township 26 North, Range 4 West Section 8, Rio Arriba County, New Mexico. The Jicarilla 119N 8A was originally granted NSL approval to cover a N/2 320.00 gas spacing unit for the Blanco Mesaverde pool on January 28, 1977, pursuant to Administrative Order 821. The order was amended to reflect a W/2 320.00 acre spacing unit on February 7, 1977. Due to a recent pay-add, it is our request that the Jicarilla 119N 8A NSL now include the Tapicito Pictured Cliffs formation. The dedicated acreage for the Tapicito Pictured Cliffs pool is the NW/4 160.00 acres of the above referenced section, township and range.

The Jicarilla 119N 8A well is closer than 660' to the western boundary of the proration unit due to moving the location prompted by adverse terrain features that were not conducive to economic construction of a well pad.

Attached is a plat depicting Energen as the offset mineral owner along the perimeter of the NW/4 of Section 8, TWP 26N, RNG 4W, accompanied by a C-102 Form.


