Gentlemen:

Gulf Oil Corporation hereby makes application for administrative approval of a 40-acre non-standard gas proration unit comprising the NE/4 SW/4 Section 29, Township 22 South, Range 38 East, Lea County, New Mexico. This non-standard unit will be dedicated to the Evelyn Lineberry Well No. 1 located 1980 feet from the south line and 1980 feet from the west line of this Section 29. The attached plat shows the proposed non-standard unit outlined in red and the unit well is circled and colored in red.

In support of this application the following facts are submitted:

- (1) Applicant's Evelyn Lineberry Well No. 1 is now assigned an 80-acre non-standard unit comprising the N/2 SW/4 Section 29-22S-38E by Administrative Order NSP-507.
- (2) Applicant's Evelyn Lineberry Well No. 2, located in the NW/4 SW/4 of this Section 29, has been recompleted as a Blinebry Oil well.
- (3) The proposed non-standard unit consists of contiguous quarter-quarter sections and lies wholly within a single governmental quarter section.
- (4) The proposed non-standard unit is reasonably presumed to be gas productive in the Blinebry Gas Pool.
- (5) The length or width does not exceed 2640 feet.
- (6) All Operators in the quarter section in which the proposed non-standard unit is located and within 1500 feet of the unit well have been furnished a copy of this application.

Dear Mr. Wright:

Reference is made to your application dated December 1, 1997 to extend the acreage of the existing 40-acre non-standard gas spacing and proration unit ("GPU") in the Blinebry Oil and Gas Pool, currently comprising the NE/4 SW/4 (Unit K) of Section 29, Township 22 South, Range 38 East, NMPM, Lea County, New Mexico, which was approved by Division Administrative Order NSP-729, dated November 22, 1965, by incorporating the 40 acres comprising the NW/4 SW/4 (Unit L) of said Section 29 into said GPU.

The existing 40-acre non-standard gas spacing and proration unit is currently dedicated to Chevron U.S.A., Inc.'s ("Chevron") Evelyn Lineberry Well No. 1 (API No. 30-025-12148), located at a standard gas well location 1980 feet from the South and West lines of said Section 29. The NW/4 SW/4 (Unit L) of said Section 29, being a standard 40-acre oil spacing and proration unit within the Blinebry Oil and Gas Pool (pursuant to Rule 2(a)2 of the "General Rules for the Prorated Gas Pools of New Mexico/Special Rules and Regulations for the Blinebry Oil And Gas Pool," as promulgated by Division Order No. R-8170, as amended, is dedicated to Chevron's Evelyn Lineberry Well No. 2 (30-025-12149), located at a standard oil well location 1980 feet from the South line and 660 feet from the West line of said Section 29. It is our understanding that the Lineberry Well No. 2 was recently reclassified from a Blinebry oil well to a Blinebry gas well whereby Chevron proposes to merge the two quarter-quarter sections in order to form a non-standard 80-acre gas spacing and proration unit in which Eumont gas production from both the Evelyn Lineberry Well Nos. 1 and 2 is to be simultaneously dedicated.

By authority granted me under the provisions of Rule 2(d) of said general gas proration/special pool rules the following described 80-acre non-standard gas spacing and proration unit is hereby approved:

LEA COUNTY, NEW MEXICO
TOWNSHIP 22 SOUTH, RANGE 38 EAST, NMPM
Section 29: N/2 NW/4.

Chevron is hereby authorized to simultaneously dedicate Blinbry gas production from both the Evelyn Lineberry Well Nos. 1 and 2. Furthermore, you are hereby permitted to produce the allowable assigned the subject GPU from both wells in any proportion.

It is further ordered that Division Administrative Order NSP-729 shall be placed in abeyance until further notice.
