Gentlemen:

Sinclair Oil & Gas Company respectfully makes application, as provided by Rule 4., for an exception to Rule 2. of the special rules for the South Vacuum Devonian Pool to allow the assignment of a 40 acre non-standard proration unit for its State Lea 403 Well No. 3 located 2,310 feet from the west line and 330 feet from the south line of Section 22, T-18-S, R-35-E, Lea County, New Mexico.

The proposed 40 acre non-standard unit would be as shown on the Form C-102, four copies of which are attached.

This exception is requested because Sinclair is drilling a well in the NE/4 of the SW/4 of Section 22, T-18-S, R-35-E, Lea County, which 40 acres is currently dedicated to our State Lea 403 Well No. 3. The well now drilling is Sinclair's State 403 Well No. 8. We anticipate dedicating 80 acres to our State Lea 403 Well No. 8, which is to be the N/2 of the SW/4 of Section 22, T-18-S, R-35-E, Lea County. An 80 acre standard unit consisting of the S/2 of the SW/4 of Section 22 is not being requested for our State Lea 403 Well No. 3 because a Devonian dry hole, our State Lea 403 Well No. 2 is located on the SW/4 of the SW/4 of Section 22.

One copy each of this application with a copy of the amended Form C-102 is being sent to the Pure Oil Company and to the Mobil Oil Company by registered mail as required by Rule 4. of the special rules for the South Vacuum Devonian Pool.

If no objection to the proposed non-standard unit is made by the offset operators, as provided in Rule 4., please grant this application.


