Continental Oil Company Application for an 40-Acre NSP Unit -State JJ-36 No. 1, Section 36, T-22S, R-37E, Lea County, New Mexico

Continental Oil Company respectfully requests Administrative Approval under the provisions of Rule 5(b) of the Special Rules and Regulations for the Blinebry Gas Pool of Order No. R-1670 for approval of an 40-acre non-standard gas proration unit for its State JJ-36 Well No. 1, located 1980' from the North line and 2030' from the East line of Section 36, T-22S, R-37E, Lea County, New Mexico in the Blinebry Gas Pool.

The unit is proposed to consist of the SW/4 NE/4 of Section 36, T-22S In support of this request we should like to point out that the R-37E. proposed unit conforms with the requirements of Rule 5(b) in all respects as follows:

- 1. Said unit consists of contiguous quarter-quarter sections and/or lots.
- 2. Said unit lies wholly within a single governmental section.
- 3. The entire proposed unit may be reasonably presumed to be productive of gas.
- 4. The length or width of said unit does not exceed 5,280 feet.
- Copies of this application have been furnished by certified mail 5. to all offset operators and all operators within 1,500 feet of said well. 1


