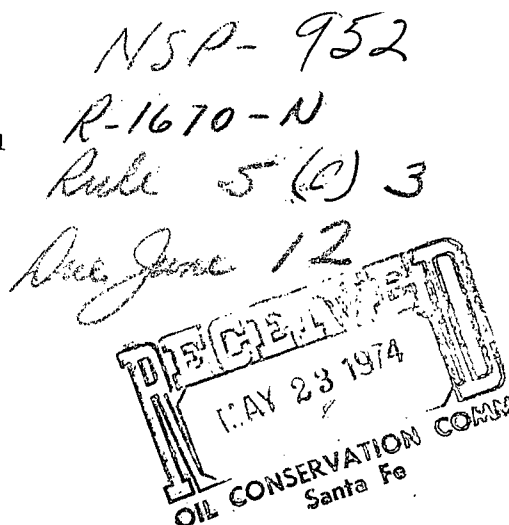

Also, I request the granting of an exception to the footage requirements of Rule 2 of the New Mexico Oil Conservation Commission Order No. R-1670-N due to the subject well being a recompletion of a well drilled previously to this Order to another formation. The New Mexico Oil Conservation Commission has previously granted dual completion of this well in your Order No. MC-2099.

The well location is as follows:

Unit Letter B, 990' FNL and 2310' FEL, Section 12,
T-22-S, R-37-E, Lea County, New Mexico.

Offset operators have been mailed a copy of this request by Certified Mail this date.

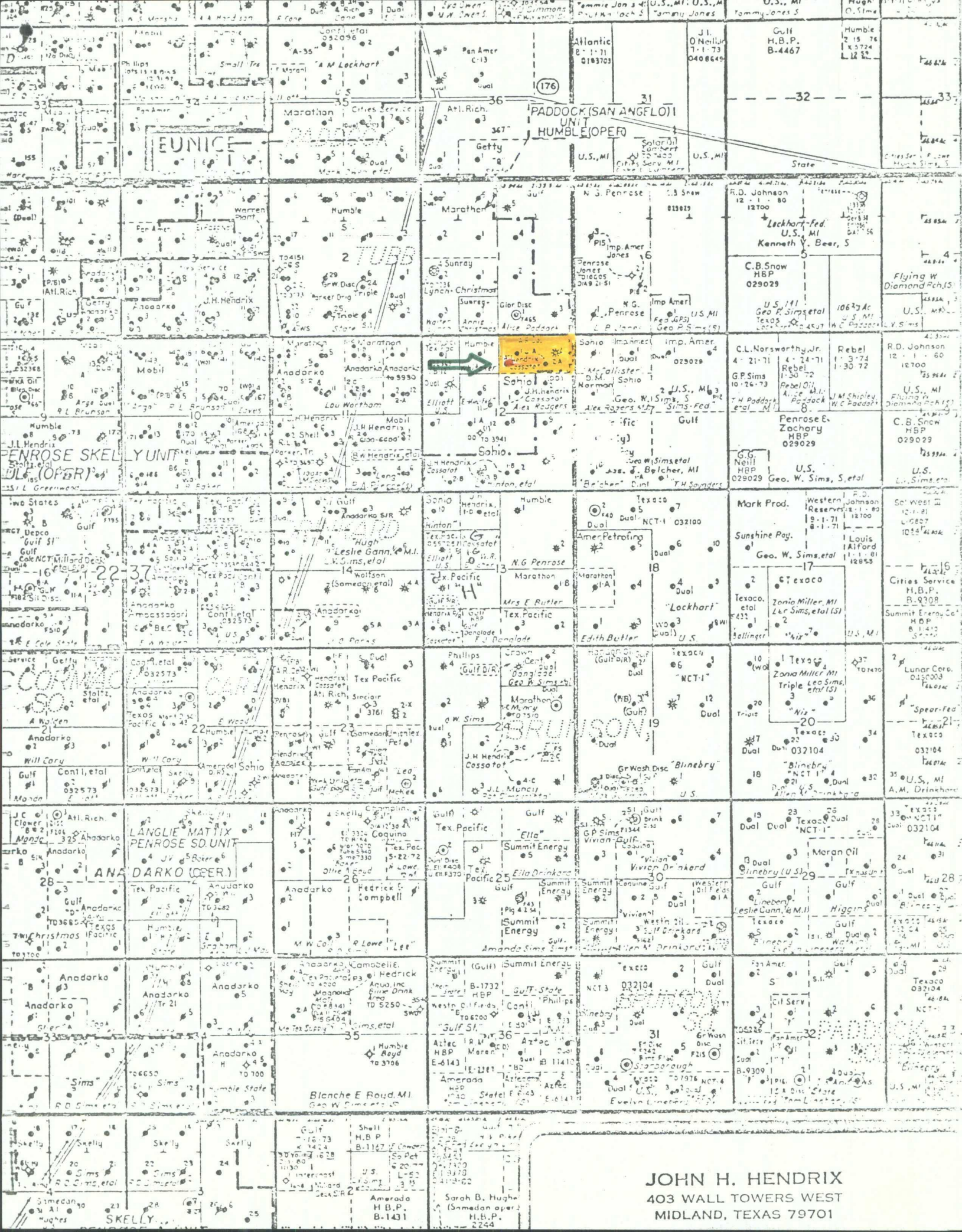

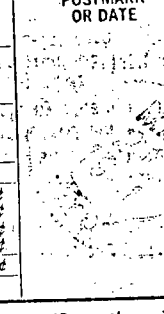

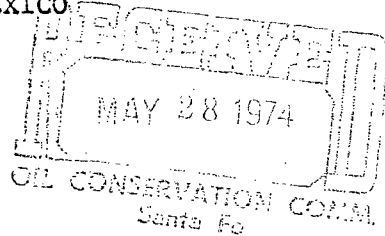

Gentlemen:

We have received, on or about June 10, a letter from John H. Hendrix dated May 21, 1974, wherein they are requesting administrative approval for a non-standard "gas proration unit" in the Blinbry Pool for their Cossatot A #1.

It is our understanding this well is located as follows:

Unit B 990' FNL and 2310' FNL, Section 12, T-22-S, R-37-E,
Lea County, New Mexico.

Sun Oil Company, as a direct diagonal operator to the Hendrix-Cossatot property, objects to the administrative approval of this request.

We have made a study of this proposal and it appears that the majority of wells in the Blinbry Pool in the immediate area are developed on standard 160-acre units, therefore we see no basis for deviation from this pattern at this time. Also, we have observed from the plat furnished by Hendrix that in the quarter-section under consideration, all but 40 acres is under lease by Hendrix and therefore it would not seem too difficult to form a conventional 160-acre unit.

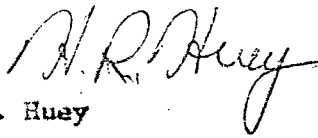
