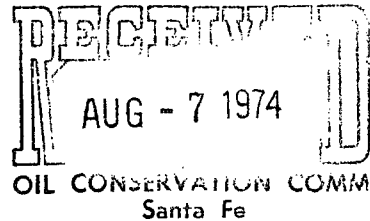

Continental Oil Company's Application for a 240-acre NSP Unit - SEMU Eumont No. 93 - Section 23, T-20S, R-37E, Lea County, New Mexico

Continental Oil Company respectfully requests administrative approval under the provisions of Rule 5 (b) of the Special Rules and Regulations for the Eumont Gas Pool of Order No. R-1670 for approval of a 240-acre Non-standard Gas Proration Unit for its SEMU Eumont No. 93 located 660' FNL 1980' FEL of Section 23, T-20S, R-37E, Lea County, New Mexico in the Eumont Gas Pool. The proposed unit is to consist of the NE/4 and the E/2 of the NW/4 of Section 23, T-20S, R-37E.

This acreage is currently dedicated to SEMU Eumont No. 68 located in Unit letter J of Section 23. The Order approving the Non-standard proration unit for SEMU Eumont No. 68 is being amended under separate application.

In support of this request, we would like to point out that the proposed unit conforms with the requirements of Rule 5 (b) in all respects as follows:

- 1) Said Unit consists of contiguous quarter/quarter sections and/or lots
- 2) Said unit lies wholly within a single governmental section
- 3) The entire proposed unit may be reasonably presumed to be productive of gas
- 4) The length or width of said unit does not exceed 5280'

A plat is attached hereto, showing to the best of our knowledge and belief, the proposed unit, the location of the well, and the offset ownership. We respectfully request that this application be handled



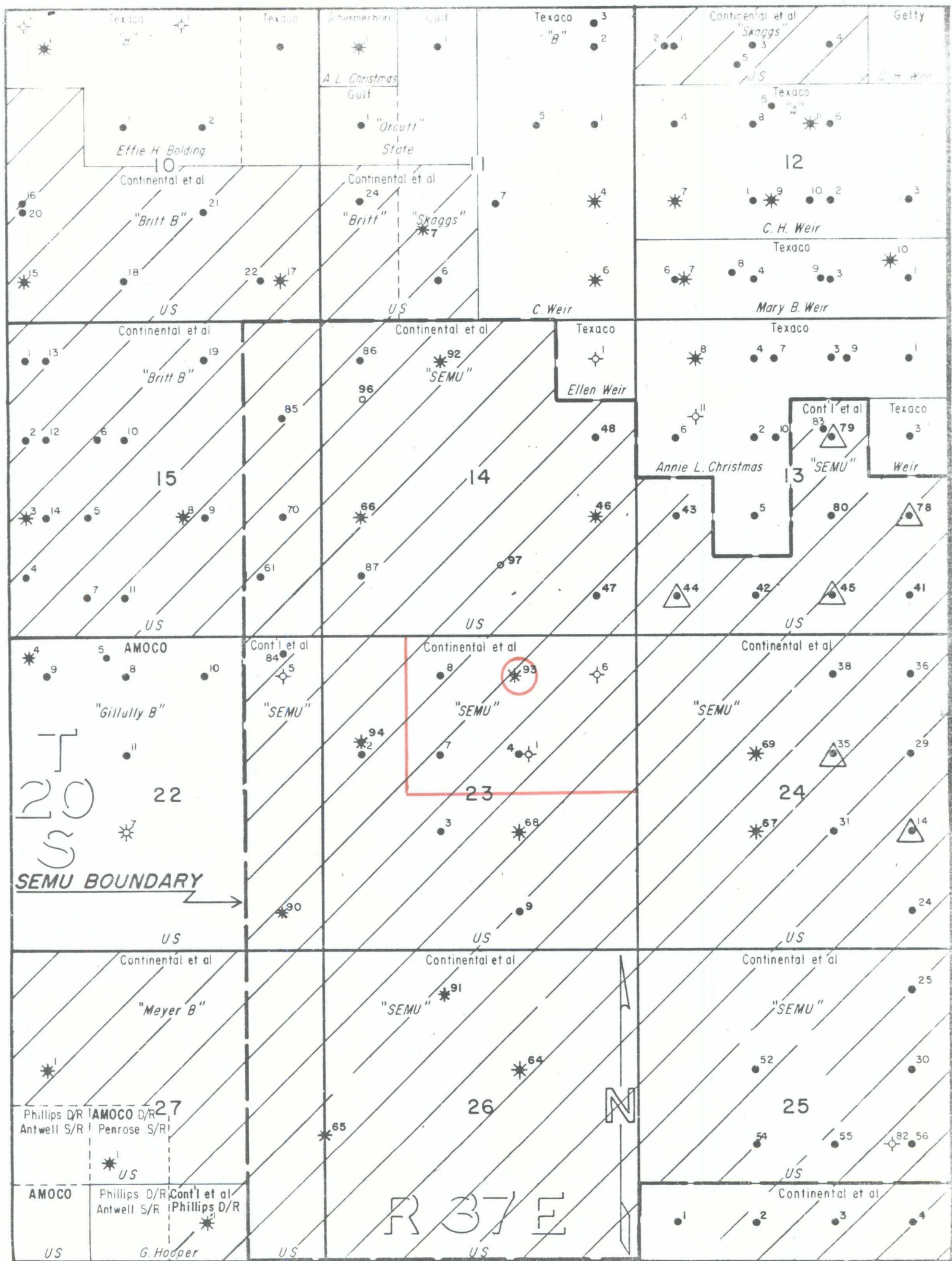

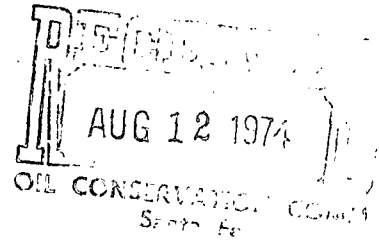
