Cliff,

The proposal to flush the draw utilizing fresh water and a "capture" system at the end of the flow path is approved with the following stipulations/conditions:

- Provide OCD with site ranking information for this release site.
- Notify OCD 48 hours prior to commencement of operations.
- Notify OCD 48 hours prior to obtaining samples where analyses of samples obtained are to be presented to OCD.
- Obtain samples from the impacted area in the arroyo before and after the flushing event.
- Remediation of impacted areas outside of the arroyo are to be by conventional methods, as proposed.
 Confirmation samples are to be obtained, analyses submitted to OCD, and approval granted prior to backfilling any excavated areas.
- Like approval by BLM.

It should be understood that this method of remediation is for the arroyo only, and is approved as an attempt at remediating this area with minimal disturbance. The success of this method will be determined after a review of the analytical data. Additional remediation efforts may be required.

Be advised OCD approval does not relieve the operator of liability should their operations have failed to adequately investigate and remediate contamination that may pose a threat to ground water, surface water, human health or the environment. In addition, OCD approval does not relieve the operator of responsibility for compliance with any other federal, state, local laws and/or regulations.
