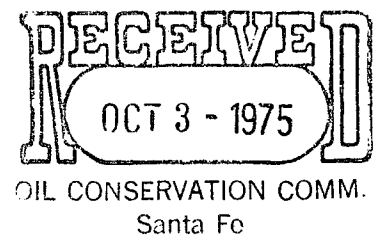

Dear Sir:

Dalport Oil Corp. drilled the #1 Owen-Federal located 1980' FNL and 660' FEL, Sec. 21, 15S-29E and completed it as a Queen gas well on 12-23-72. It was subsequently placed in a 320-acre unit comprising the E $\frac{1}{2}$, Sec. 21 in the Southeast Chaves Queen Field.

We are going to drill a Queen oil well 330' FN and EL of this section, which would thereby reduce the acreage dedicated to the #1 Owen-Federal gas well to 280 acres.

In accordance with R-44 35-A, Rule 3, concerning the Southeast Chaves Queen Gas Area, we respectfully request administrative approval of a 280-acre non-standard gas unit which will be dedicated to the existing Dalport Oil Corporation #1 Owen-Federal, 1980' FNL and 660' FEL, Sec. 21, 15S-29E.

Enclosed are three copies each of original C-102 and area plat, as well as, certified mail receipts showing notification of offsetting operators.
