Gentlemen:

On May 26, 1958, Administrative Order No. R-1176 (Case No. 1426) was approved by the NMOCC for the establishment of a 120 Acre Non-Standard Blinbry Gas Unit consisting of the S/2 SE/4 and SE/4 SW/4 of Section 17, T-21-S, R-37-E, Lea County, New Mexico. Percy Hardy Well No. 1 in Unit P was designated as the Unit Well for the above described Unit.

The Percy Hardy Wells Nos. 1 and 3 were reclassified to Blinbry Gas Wells effective January 1, 1972. In order to comply with provisions of Order No. 1670 pertaining to the Blinbry Gas Pool, Getty requested a 40 Acre Non-Standard Gas Unit for Percy Hardy Well No. 3 located in Unit N. This 40 Acre Non-Standard Unit was granted by Administrative Order No. NSP-855 on January 21, 1972. Percy Hardy Well No. 1 was shut-in.

On March 14, 1972, Getty requested Administrative Approval of this 120 Acres being reassigned to our Percy Hardy Wells Nos. 1 and 3. Percy Hardy Well No. 2 was shut-in. This Application was granted by Administrative Order NSP-877 on April 18, 1972.

Remedial work was done on Percy Hardy Well No. 2 in January and February, 1975 and Well No. 2 was classified as a Blinbry Gas Well.

Getty Oil Company requested that this 120 Acre Non-Standard Gas Proration Unit being S/2 SE/4 and SE/4 SW/4 of Section 17, T-21-S, R-37-E, be allocated to the Percy Hardy Well No. 1 (Unit P); Well No. 2 (Unit O); and Well No. 3 (Unit N) located in Section 17, the allowable from which to be produced from any well in any proportion. This Application was granted by NMOCC Administrative Order NSP-994.

On November 14, 1975 the NMOCC reclassified Percy Hardy Well No. 1 (Unit P, Section 17, T-21-S, R-37-E) to an oil well. (See Attached - No. 2)
