The New Mexico Oil Conservation Division (OCD) has received Plains' report and request for soil closure of the above-referenced site (dated March 2010). The above-referenced report, submitted in partial fulfillment of 19.15.30.19 NMAC (Part 30.19, formally, Rule 19.K), indicates that Plains has partially met the requirements of 19.15.30.9 NMAC for this site. Therefore, the OCD hereby conditionally approves the Soil Closure Request for the HDO 90-23 Release Site and no further soil remediation is required for this site:

Plains must install a soil boring at least 40 feet bgs in June or July of **2011**. The soil boring must be located within 20 feet of MW-2. Soil samples at 5-foot intervals from the boring must be analyzed for TPH and the analytical results must be submitted to the OCD within 60 days of the installation.

Plains must install a soil boring at least 40 feet bgs in November or December of **2012**. The soil boring must be located within 20 feet of MW-2. Soil samples at 5-foot intervals from the boring must be analyzed for TPH and the analytical results must be submitted to the OCD within 60 days of the installation.

The Plains HDO 90-23 Release Site is still active under Abatement Plan, AP-009, and groundwater monitoring, further groundwater contamination delineation if warranted, and groundwater remediation must continue at the Plains HDO 90-23 Release Site.
